Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN BOX HILL FOR THE ANGEL OF MINE FILM SHOOT ON 6 AND 7 JUNE 2018

1 Purpose

The purpose of this Declaration is to exempt participants in the Angel of Mine Film Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on 6 and 7 June 2018.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect on 6 June 2018.

4 Expiry

This notice expires at 11.59 pm on 7 June 2018.

5 Definitions

In this notice, unless the context or subject matter otherwise requires –

- a) 'Event' means the Angel of Mine Film Shoot to be held on 6 and 7 June 2018; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of the SixtyFourSixty AOM Production Ptd Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, Anita Curnow, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
