



# ROAD DISCONTINUANCE

Pursuant to section 206 and Schedule 10, Clause 3 of the **Local Government Act 1989**, Greater Dandenong City Council, at its ordinary meeting held on 29 January 2018, formed the opinion that the road located at the rear of 98–102 Kirkham Road, Dandenong, shown hatched on the plan below (Land), is not reasonably required as a road for public use.
