## TRANSFER OF PROPERTY, RIGHTS AND LIABILITIES FROM THE ROADS CORPORATION TO THE MAJOR ROAD PROJECTS AUTHORITY

Order in Council

The Governor in Council under section 66B of the **Transport Integration Act 2010** orders that the property, rights and liabilities of the Roads Corporation specified in Schedules 1 and 2 to this Order be transferred to the Major Road Projects Authority acting on behalf of the Crown in right of the State of Victoria.

This Order takes effect on 6 August 2018.
