



#### EXEMPTION

#### Application No. H165/2018

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Yarra Valley Grammar School (the applicant). The application for exemption is to: enable the applicant to advertise for prospective female students to commence in the years 2019 to 2023 inclusive; give preference to female students on its waiting lists where vacancies arise in all year levels up to 45% of the total number of students in each year; and cap the enrolment of male students at each year level at 55% of all students to be enrolled in that year level for the years 2019 to 2023 inclusive (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Mark Merry, principal, having heard evidence from Dr Merry, having heard submissions made on behalf of the applicant, and having had regard to the requirements of the Act, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 38, 44, 107, and 182 of the Act to enable the applicant to engage in the exempt conduct. In granting this exemption, the Tribunal noted:

- The applicant opened as a single-sex boys school in 1966. Female students were first enrolled at some levels in 1978 and the school became fully co-educational in 1994. The school now offers co-education at all levels.
- Dr Merry's evidence, which I accept, established relevant facts about the applicant's history as a co-educational school, which are set out below.
- Co-education was introduced because the school believes it is beneficial to students for their general development and their personal development, particularly in developing relationships and building self-esteem.
- In 1999, there was still a significant disparity between male and female student numbers and the school sought and was granted an exemption under the legislation at that time. This allowed it to advertise for prospective female students, structure waiting lists and allocate places preferentially to females, cap the level of male enrolments and offer targeted scholarships to female students.
- A similar exemption was granted when the school applied in 2004. Then, although the gender balance had improved, there was still a disparity in the number of male and female students.
- Since 2004, the proportion of female students has increased. Also, since then, the applicant has taken steps to increase the numbers of female students in ways other than those which require exemption from the Act. It has established and maintained gender neutral curricula, encouraged females to take up leadership positions within the school and facilitated female-oriented sport, including girls 'football, soccer, basketball and volleyball.
- While the number of female students has increased, the student numbers have grown overall so that the proportion of girls has not increased greatly overall. In 2018, of the students enrolled, 61% are male and 39% female. At some levels, there is only a modest difference in the numbers of male and female students and at others it is larger, even at one level as much as 26%.
- The school considers a realistic goal over the next few years is that it reaches 45% female enrolments. The school projects, based on current waiting list data that it will be unable to reach that goal without an exemption to allow it to advertise for and give preference to female students to some extent and cap the proportion of male students at each level.
- None of the exceptions provided by the Act apply to the conduct proposed by the school. Without an exemption, the conduct would amount to prohibited discrimination, so the exemption is necessary.
- When making decisions about exemptions, the Tribunal is required to consider relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right of potential students to equal and effective protection against discrimination on the basis of sex. I am satisfied that, in the circumstances discussed above, the limitation imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 38, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force to 23 August 2023.

## EXEMPTION

#### Application No. H177/2018

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Georgina Martina Incorporated (the applicant). The application for exemption is to enable the applicant to advertise for and employ only women (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Lisa Anne Dunbar and having had regard to the requirements of the Act, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 107, and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal accepted the evidence of Ms Dunbar and noted:

- The applicant operates as a high security, 24-hour women's refuge program, funded through the Victorian Department of Health and Human Services. The applicant provides emergency accommodation and support services for women (in some cases accompanied by their children) who are escaping family violence.
- The services are delivered in a communal setting; staff offices are on site and meetings with the applicant's board of management and administration staff are also on site. Staff sleep overnight on the premises, providing a 24-hour service.
- Many of the applicant's clients come from culturally diverse backgrounds and would not be comfortable sharing premises with men who are not part of their family. For example, Muslim clients would have to be totally covered and would not be able to treat the refuge as a home.
- Some of the applicant's clients (both women and children) are recovering from the trauma and other effects of family violence and require a place where they can feel absolutely safe to recover. Some are uncomfortable in the presence of men when they are recovering from male violence. At such times, the applicant's women clients rely on the support of women in developing resilience and building a safe future for themselves and their children.
- The applicant's staff often speak with clients of very sensitive issues (such as rape and sexual and physical assault) and assist with affidavits including detailed examples and photographs of injuries. These conversations are of a very personal nature and the applicant's clients are not comfortable discussing these matters in the presence of males.
- The applicant was granted an exemption in 2012 and seeks a further exemption to allow it to employ only women.
- None of the exceptions provided by the Act apply to the conduct proposed by the applicant. Although section 28 of the Act provides some exceptions for employment of people with a particular attribute in services providing for clients with special needs, the evidence is not sufficient to establish that the complete exclusion of male employees falls within that exception. Accordingly, without an exemption, the conduct would amount to prohibited discrimination, so the exemption is necessary.
- When making decisions about exemptions, the Tribunal is required to consider relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right of potential employees to equal and effective protection against discrimination on the basis of sex. I am satisfied that, in the circumstances discussed above, the limitation imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force to 23 August 2023.
