## **Transport (Compliance and Miscellaneous) Act 1983**

### CONDITIONS UNDER SECTION 220D

I, Richard Bolt, Secretary to the Department of Economic Development, Jobs, Transport and Resources, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determine the following conditions (the 2018 Amending Conditions No. 2) which amend the conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victoria Fares and Ticketing Manual (effective 1 January 2018) published in the Victorian Government Gazette No. S. 457 dated Friday 22 December 2017, and amended by the 2018 Amending Conditions No. 1 dated 27 February 2018.

The 2018 Amending Conditions No. 2 take effect from and including 26 August 2018.

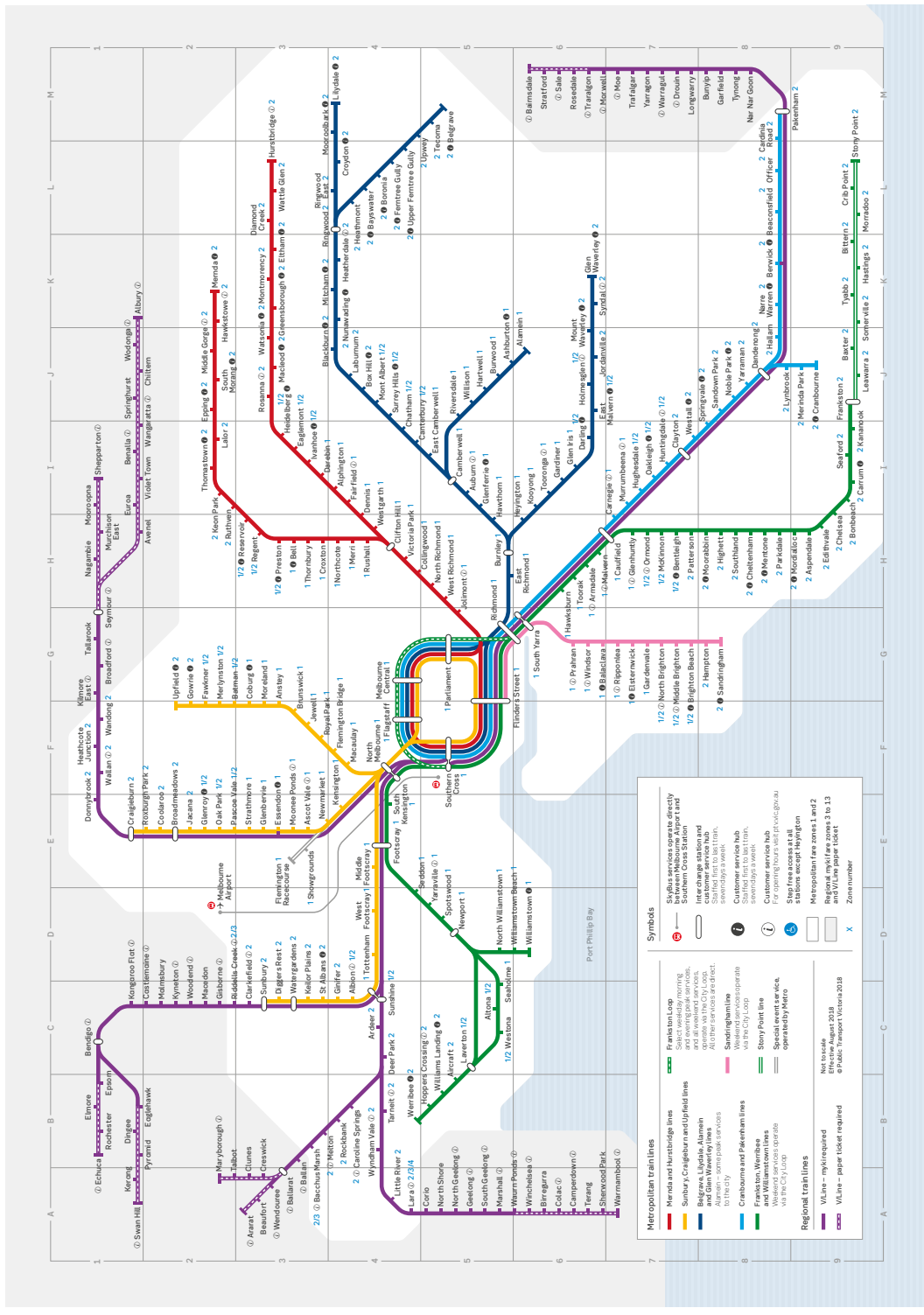

## 2018 AMENDING CONDITIONS NO. 2

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** contained in the Victorian Fares and Ticketing Manual (effective 1 January 2018) published in the Victoria Government Gazette No. S. 457 dated Friday 22 December 2017 (the Manual), and amended by the 2018 Amending Conditions No. 1 dated 27 February 2018, are amended as follows.

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Manual and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.

In Chapter 9 of the Manual, under the heading ‘**Melbourne train network map**’ substitute the image with the following map image –
