

#### **EXEMPTION**

## Application No. H143/2018

InTouch Multicultural Centre Against Family Violence applied to the Victorian Civil and Administrative Tribunal under to section 89 of the **Equal Opportunity Act 2010** (the Act) for an exemption to advertise for and employ: (a) Only women in certain roles within the organisation, and (b) Only persons of specified cultural or racial backgrounds to undertake certain roles within the organisation (the exempt conduct).

The Executive Manager Galina Kozoolin filed an affidavit and other material in support of this application. The applicant was the subject of similar exemptions from 14 January 2008 to 1 January 2011 and from 13 August 2012 to 15 August 2017. The Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The applicant provides advocacy and other services to women and children experiencing family
  violence. The applicant wishes to employ women in case work, legal, reception, administrative
  and other roles. There are occasions when the applicant employs men, for example in perpetrator
  intervention programs. The applicant employs persons from non-English speaking backgrounds.
- The applicant cited research which shows that the majority of family violence against women is perpetrated by men. This is reflected in the clientele of the service, noting that 90% of referrals relate to women seeking assistance for family violence and the majority of those women report abuse by their male partners. The applicant stated that consultations with clients relate to sensitive issues that affect women and children's safety and wellbeing and that this requires staff with cultural understanding and excellent communication skills.
- Submissions by the applicant satisfied me that isolation, lack of familiarity with local laws
  and procedures, fears of the impact of making reports on residency and migration status and
  complex cultural consequences of reporting abuse mean that their clients face barriers in seeking
  legal assistance and require specialised services from persons with a particular skill-set and life
  experience which can only be provided by women from non-English speaking backgrounds.
- The Victorian Equal Opportunity and Human Rights Commission indicated it would not intervene in the proceedings.
- It is appropriate to grant an exemption as otherwise the exempt conduct may amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the Charter of Human Rights and Responsibilities Act 2006 (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of males or persons from English speaking backgrounds who would wish to be employed by the applicant. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from 30 August 2018 until 29 August 2023.





DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN SURFCOAST SHIRE AND COLAC OTWAY SHIRE FOR THE 2018 AMY'S GRAN FONDO ON SATURDAY 15 SEPTEMBER 2018 AND SUNDAY 16 SEPTEMBER 2018

#### NOTICE OF DECISION

Child Wellbeing and Safety (Information Sharing) Regulations 2018

I, Jenny Mikakos, Minister for Families and Children, and Minister responsible for administering the **Child Wellbeing and Safety Act 2005** (the Act), give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to make the proposed Child Wellbeing and Safety (Information Sharing) Regulations 2018 (the proposed Regulations).

The objectives of the proposed Regulations are to prescribe:

- the information sharing entities that can share information with one another for the purpose of promoting the wellbeing and safety of children;
- the record keeping requirements of those information sharing entities; and
- the secrecy and confidentiality provisions to allow information sharing under new Part 6A of the Act within the existing Victorian privacy framework.

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Regulations. A copy of the RIS and an Exposure Draft of the proposed Regulations was published at https://engage.vic.gov.au, on 16 May 2018 and notice of the RIS was published in the Government Gazette and The Age newspaper on 18 May 2018 inviting public comment. The 28 day comment period ended on 15 June 2018.

Written submissions in response to the RIS and proposed Regulations were received from 29 stakeholder groups, representing 32 stakeholders, and all were considered. The key issues raised related to:

- Delaying the commencement date of the proposed regulations;
- Introducing additional information sharing entities;
- Including additional record keeping obligations;
- Expanding the categories of excluded information; and
- Underestimating the estimated costs to information sharing entities in the RIS.

After consideration of the submissions received, I have decided that the proposed Regulations should be made with the following amendments:

- An amendment to the commencement date from 3 September 2018 to 27 September 2018, to support sector readiness for prescribed workforces
- The inclusion of additional information sharing entities, being
  - authorised Hub entities; and
  - family violence perpetrator intervention programs and services
- removal of the Children's Court and Magistrates' Court as information sharing entities, subject to further consultation with these courts; and
- minor and technical amendments for the purpose of drafting consistency and clarity.

## **Veterinary Practice Act 1997**

## VETERINARY PRACTITIONERS REGISTRATION BOARD OF VICTORIA

#### Notice

Re: Dr Brian Colin Clarke

On 15 June 2018, a Panel of the Veterinary Practitioners Registration Board of Victoria ('the Board') concluded a Formal Hearing into the professional conduct of Dr Brian Colin Clarke, a registered veterinary practitioner.

Pursuant to section 45(1) of the **Veterinary Practice Act 1997** ('the Act'), the Panel found that Dr Clarke had, on multiple occasions relating to three separate complaints, engaged in unprofessional conduct of a serious nature within the meaning of paragraphs (a) and (b) of the definitions of unprofessional conduct contained in section 3 of the Act.

The Panel made the following determinations:

- 1. That Dr Clarke's registration as a veterinary practitioner be suspended until 31 December 2019.
- 2. That Dr Clarke is reprimanded.
- 3. That, prior to the completion of his suspension period, Dr Clarke undergo counselling in the following areas:
  - psychological and mental well-being
  - animal welfare
  - business operations.
- 4. That Dr Clarke undertake comprehensive education before the completion of his period of suspension in the following areas:
  - peri-operative management of the surgical patient
  - practical surgery skills
  - pharmacology
  - recognition and treatment of shock and fluid therapy
  - anaesthesia and pain management
  - animal welfare.
- 5. That, for the first six months after returning to practice after completing his suspension period, Dr Clarke's registration be subject to the following conditions:
  - that he work under supervision in an animal welfare organisation (such as the RSPCA), such supervision to determine whether he should or should not be the subject of any further conditions or supervising period;
  - that he undertake and successfully complete the multiple-choice question element of the National Veterinary Exam; and
  - that he demonstrate to the Board that any practice that he works in has a medical records system compliant with the Board's Guidelines.
- 6. That Dr Clarke pay the reasonable costs of, and incidental to, the Formal Hearing in the sum of \$24,000.

## **Education and Training Reform Act 2006**

APPOINTMENT OF A CHAIRPERSON TO THE ADULT, COMMUNITY AND FURTHER EDUCATION BOARD SCHEDULE TO THE ORDER IN COUNCIL

#### 1. Appointment Arrangements

The Chairperson is appointed on a part-time basis.

## 2. Period of Appointment

The period of appointment is from the date of this Order until 1 August 2021 (both dates inclusive).

## 3. Duties and responsibilities of the position

The functions and powers of the Adult, Community and Further Education Board (the Board) are provided under Division 2 of Part 3.3 of the **Education and Training Reform Act 2006** (the Act).

The functions of the Adult, Community and Further Education Board (the Board) include inquiring into and making reports on the development of policies, programs and services regarding providing adult, community and further education; planning, developing, evaluating and funding policies, programs and services for the co-ordination, provision and support of adult, community and further education; providing for the delivery of adult, community and further education; and advising the Minister on any matter relating to adult, community and further education.

The Board also has certain financial powers, including the ability to make payments by way of grants, subsidies or loans in relation to adult, community and further education.

### 4. Termination Arrangements

Clause 2(3) of Schedule 2 to the Act, stipulates that the office of a member becomes vacant if the member becomes bankrupt, is found guilty of an offence which is, or which would if committed in Victoria be, an indictable offence or is absent from three consecutive meetings of the Board without the leave of the Chairperson or in the case of the Chairperson without the Minister's leave.

## 5. Payment Provisions

Under clause 3(1) of Schedule 2 to the Act the members of the Board, other than a member who holds a full-time Government office, or a full-time position in the public service, teaching service or with a statutory authority (other than a university), are entitled to receive the remuneration and fees that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council.

The remuneration for eligible Chairpersons is fixed at the annual fee of \$39,913. The appointee is eligible for remuneration.

#### 6. Superannuation Obligations

Superannuation will be paid in accordance with the Superannuation Guarantee (Administration) Act 1992.

## 7. Travel and Personal Expenses arrangements

The appointee referred to in this Order may be reimbursed for reasonable out of pocket expenses such as travelling, accommodation, meals and other incidental expenses associated with attendance at meetings, overnight absence from home or absence from the normal work location in the course of field duties. Such reimbursement will be in accordance with relevant policies of the Department of Education and Training.

## 8. Leave Arrangements

There are no leave provisions for this part-time statutory position.

#### 9. Prior Service

Prior service is not applicable for long service or leave entitlement.
