Greater Shepparton City Council has prepared Amendment C211 to the Greater Shepparton Planning Scheme.

The Amendment applies to approximately 70 hectares of land and the following addresses:

- 85 and 110 Packham Street, Shepparton;
- 120–174 Numurkah Road, Shepparton;
- 20 and 20A Mercury Drive, Shepparton;
- 55, 55A and 75 Wanganui Road, Shepparton; and
- part of 45 Parkside Drive, Shepparton.

The Amendment proposes to insert a new Incorporated Document titled *Munarra Centre for Regional Excellence and Shepparton Sports and Events Centre, October 2018* in the Greater Shepparton Planning Scheme. The Hobsons Bay City Council has prepared Amendment C113 to the Hobsons Bay Planning Scheme.

EXEMPTION

Application No. H311/2018

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Gippsland Women's Health Incorporated (the applicant). The application for exemption is to enable the applicant to advertise for and employ only women within the organisation and to provide services, including membership related services, to women only (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavits of Fiona Owen, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant is a community-based organisation funded through the Department of Health and Human Services' Women's Health Program to provide health promotion programs, community and professional education, research and health information services to women across Gippsland. It aims to improve the health and wellbeing of women in Gippsland, particularly in regard to sexual and reproductive health, mental health and wellbeing and prevention of violence against women.
- The applicant's key purposes include assisting women on health issues, responding to the needs of women who experience disadvantage and discrimination and treating women with dignity and respect. There is a focus on the needs of women who have limited access to health services including Koori women, women from culturally and linguistically diverse backgrounds, women with disabilities and rural women.
- By employing women only, the applicant has the capacity to develop gender sensitive services and programs that meet the needs of women and can provide a safe and accessible and non-threatening environment for women to obtain relevant information. Through providing services to women only, the applicant can ensure that the needs of women are identified and are paramount in the development of the delivery of the services.
- The applicant contends that it is imperative to the success of the organisation's objectives that its decision-making processes are undertaken in a way that is uniquely female and is focussed on women's health. Decision-making can often require discussion of sensitive topics or experiences which I infer may be impeded if employees had to discuss such topics and experiences in the presence of males and therefore lead to poorer decisions.
- The exception contained in section 88 of the Act in respect of special needs services applies to some of the services provided by the applicant, but not all. To the extent that some of the services provided may not fall within the exception, an exemption would be required.
- Where staff of the applicant only work with women providing direct special needs services relating to those women's health concerns, the exception contained in section 28 of the Act would apply. That is because the evidence would support a finding that those services are likely to be most effectively provided by other women. However, I am not satisfied that all other services provided by the applicant, can be provided most effectively by women only. Where I am not satisfied that an exception applies to the whole of the exempt conduct but accept that it is likely to preferable that women only work for the applicant, it is appropriate that an exemption be granted.
- The applicant was granted an exemption in relation to advertising and employing female only employees in 2007 (A261/2007) and a further exemption in respect of that conduct was granted in 2010 (A244/2010). The latter exemption expired on 8 September 2013. An interim exemption was granted on 24 October 2018 until 22 February 2019. In the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of men who would wish to be employed by the applicant or receive services from the applicant. The applicant notes that men will not be disadvantaged by the exemption because there are equivalent gender-specific services available to Victorian men. I am satisfied for the purposes of an exemption, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 18 January 2022.

The changes were made to comply with Australia's international trade agreements and the requirements of the Trans-Pacific Partnership (TPP-11), to which Australia is currently a signatory, that came into effect on 30 December 2018.

The Governance policy has introduced additional wording requiring mandated organisations to ensure that their procurement governance framework includes measures that implement a dispute resolution mechanism as required by Australia's international trade agreements.

The Complexity and capability assessment policy includes revised wording to reflect a minor change to replace 'local business' with 'Australia and New Zealand small to medium enterprises (SMEs)' to reflect the definition of local in accordance with Australia's international trade agreement requirements.

The Market approach policy includes revised wording reflecting minor changes to:

- clarify that specifications can be structured to have relevance to Australian and New Zealand SMEs where appropriate; and
- remove the reference to 'Australian standards' to comply with Australia's international trade agreement obligations to accord treatment no less favourable to the goods, services and suppliers of another party to relevant international agreements than the treatment accorded to domestic goods, services and suppliers.

The policy changes were subject to extensive consultation with legal representation and departments.

Plant Biosecurity Act 2010**ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION INTO VICTORIA OF MATERIALS WHICH ARE HOSTS OF EUROPEAN HOUSE BORER**

I, Rosa Crnov, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic pest European house borer exists within Australia but outside Victoria, make the following Order:

1 Objective

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of materials which are hosts of European house borer.

2 Authorising Provision

This Order is made under section 36(1) of the **Plant Biosecurity Act 2010** (the Act).

3 Commencement

This Order comes into operation on the date of making.

4 Revocation

The Order made under section 36(1) of the **Plant Biosecurity Act 2010**, prohibiting or restricting the entry or importation of European house borer host materials into Victoria, and published in Victoria Government Gazette G5 (pages 171–173) on 1 February 2018, is **revoked**.

5 Definitions

In this Order –

‘**European house borer**’ means the exotic pest *Hylotrupes bajulus* (Linnaeus);

‘**host material**’ means any pinewood, including pallets, packing materials and structural pinewood, but excluding items made only from reconstituted pinewood, any pinewood product made only of heartwood, any pinewood product less than 4 millimetres thick, or pinewood household articles and furniture imported by or on behalf of a person for the personal use of the person or a member of the person’s household (e.g. moving household furniture);

‘**pinewood**’ means any wood from trees of the genera *Abies* (Mill), *Picea* (Mill), *Pinus* (L.), *Araucaria* (Juss) or *Pseudotsuga* (Carriere);

‘**structural pinewood**’ means any pinewood which is part of an existing building or is to be used in the construction of a building.

6 Prohibitions, restrictions and conditions

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of host material.

- (a) The entry or importation into Victoria of any host material is prohibited.
- (b) Sub-clause (a) does not apply if the host material:
 - (i) originates from an area for which there is currently in force an area freedom certificate issued by an officer responsible for agriculture in the State or Territory from which the material originated, certifying that the area from which the material originated is known to be free of European house borer; or
 - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the material has been treated in a manner described in the Schedule to this Order; or
 - (iii) enters Victoria under and in accordance with a permit issued by an inspector and there is compliance with any conditions or requirements set out in the permit.

7 Verification of consignments

Where requested by an authorised inspector, host material imported into Victoria, which is required by clause 6(b)(ii) to be accompanied by a certificate or declaration, must be presented to an authorised inspector for inspection.

8 Expiry

This Order remains in force for a period of 12 months after the date of making.

Schedule

Host material must –

- (1) be treated –
- with a preservative specific for European house borer, and to a hazard class of H2 or greater as provided in the AS/NZS 1604 series ‘*Specification for preservative treatment*’; or
 - by heating so that the core temperature at the product’s greatest thickness, remains at or above 56°C for not less than 30 minutes, where treatment has occurred not more than 21 days prior to the host material’s arrival in Victoria; or
 - in the case where the cross section measures less than 20 centimetres, with methyl bromide in accordance with the following table and where treatment has occurred within 21 days prior to the arrival in Victoria; and

Temperature	Minimum concentration dosage (g/m ³) at:				
	Start	2 hours	4 hours	12 hours	24 hours
21°C or above	48	36	31	28	24
16°C or above	56	42	36	32	28
10°C or above	64	48	42	36	32

- (2) in the case of structural pinewood, stored so as to prevent infestation:
- in a secure building, which has been inspected and approved by an authorised officer as being suitable for the purpose of excluding European house borer; or
 - by fully wrapping in plastic film which is not ripped, torn or otherwise damaged; or
- (3) in the case of pallets, be sourced from a supplier approved under a scheme administered by Quarantine Western Australia.

Notes:

Section 38 of the Act provides that it is an offence for a person to cause, permit or assist any plant, plant product, plant vector, used equipment, used package, earth material or beehive to enter, or be imported into, Victoria in contravention of an importation order under section 36. The maximum penalty of 60 penalty units applies in the case of a natural person, and 300 penalty units in the case of a body corporate.

Terms in this Order that are defined in the Act have that meaning.

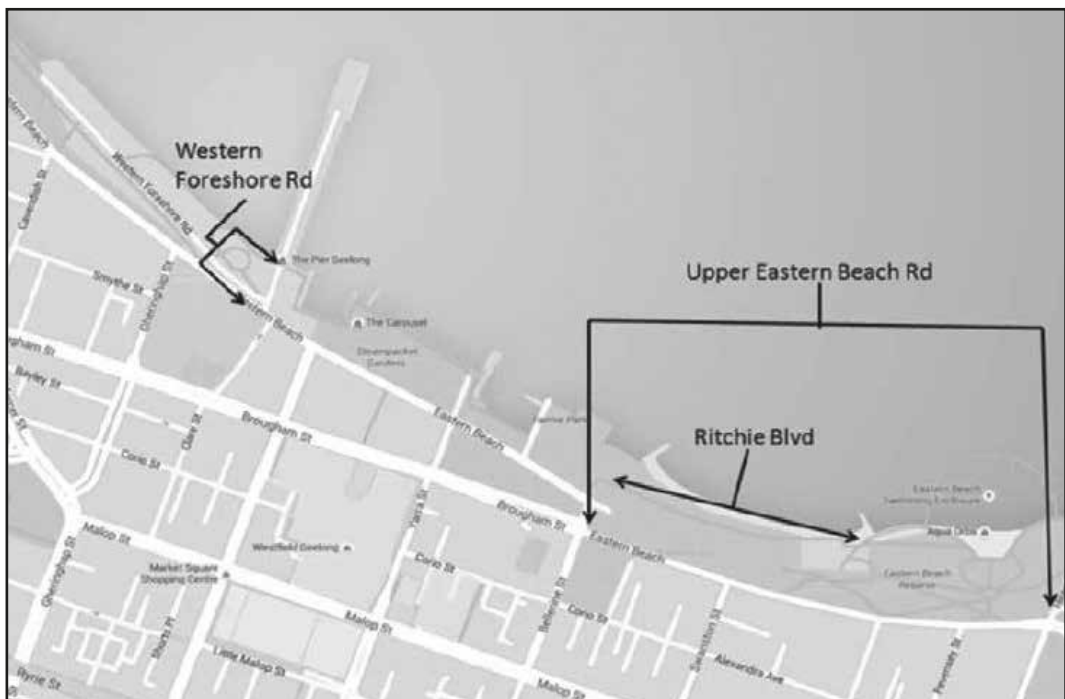

DECLARATION OF PUBLIC SAFETY ZONES

I, Alison Ireland, Assistant Chief Fire Officer, Gippsland Region, as delegate of the Secretary to the Department of Environment Land Water and Planning, make the following declaration of public safety zone under section 4(1) of the **Safety on Public Land Act 2004**.

1. Definitions

In this declaration:

- (a) ‘the Act’ means the **Safety on Public Land Act 2004**;
- (b) ‘the declared public safety zone’ means the area declared under clause 2 of this declaration;
- (c) ‘MGA’ means the Map Grid of Australia;
- (d) ‘Zone 55’ means Zone 55 of the Map Grid of Australia.

2. Declaration of Public Safety Zones

The land to which the declaration refers is the land referred to on the plan filed in the Central Plans Office reference LEGL./18-418, which incorporates the Thomson River Fishway works area within the Erica State Forest, Coopers Creek Copper Mines Historic and Cultural Features Reserve and Erica–Thomson Rail Trail Reserve.

3. Purpose for which the area has been declared

The purpose for which the public safety zone has been declared is for the maintenance of public safety due to the construction works associated with the Thomson River Fishway.

4. Period of the declaration

The period for which the public safety zone is declared is commencing from 1 February 2019 and ending on 31 August 2019 inclusive or the completion of construction and rehabilitation works of the Fishway.

5. Activities prohibited

The activities that are prohibited in the declared public safety zones are:

- (a) Knowingly entering a declared public safety zone during a period when access is prohibited; and
- (b) Knowingly remaining in or being present in a declared public safety zone during a period when access is prohibited.

6. Periods when access is prohibited

The times during which access to the declared public safety zone is prohibited is the period of declaration.

7. Exempt persons or classes of person

Pursuant to section 5(2) of the Act, the following persons or classes of person are exempt from the operation of this declaration:

- (a) Employees, agents and contractors of the Department of Environment, Land, Water and Planning as well as staff and contractors of the West Gippsland Catchment Management Authority engaged in carrying out their functions with authorisation from the Department of Environment, Land, Water and Planning Latrobe District Manager.

It implements the Lancefield Road Precinct Structure Plan, June 2018 that will facilitate development of land for residential and employment uses and deliver necessary community infrastructure in accordance with the PSP.

Specifically, the Amendment inserts Schedule 10 to 37.07 Urban Growth Zone (UGZ10) into the Hume Planning Scheme and rezones land from Urban Growth Zone (UGZ) to Urban Growth Zone Schedule 10 (UGZ10) to part of the land within the Amendment area; rezones land from Rural Conservation Zone Schedule 1 (RCZ1) to Rural Conservation Zone (no schedule) (RCZ) to part of the land within the Amendment area; rezones land from Rural Conservation Zone Schedule 1 (RCZ1) to Urban Growth Zone Schedule 10 (UGZ10) to part of the land within the Amendment area; rezones land from Urban Growth Zone (UGZ) to Rural Conservation Zone (RCZ) to a portion of the land within the Amendment area; applies the Rural Conservation Zone (RCZ) to land within the Amendment area which falls within conservation areas under the 'Biodiversity Conservation Strategy' and areas of regionally significant landscape values; deletes Environmental Significance Overlay Schedule 1 (ESO1) from land within the Amendment area and Schedule 10 (ESO10) from parts of the land within the Amendment area; applies Environmental Significance Overlay Schedule 10 (ESO10) to land within the Amendment area which falls within the 'Biodiversity Conservation Strategy' conservation area; applies the IPO3 to land within the Amendment area which falls within conservation areas under the 'Biodiversity Conservation Strategy'; applies the IPO4 to land within the Amendment area which will be zoned Rural Conservation Zone (RCZ) outside of the 'Biodiversity Conservation Areas' and land to remain zoned as Urban Floodway Zone (UFZ); deletes part of the existing Public Acquisition Overlay Schedule 2 (PAO2); amends the Schedule to Clause 45.12 to include two new incorporated documents and makes associated mapping changes; amends the Schedule to Clause 52.02 to remove restrictive covenants contained in Instrument of Transfer No. V178361Y from 5 Stockwell Drive, Sunbury (Lot 2 on PS403051); and instrument of Transfer No. V161817C from 11 Stockwell Drive, Sunbury (Lot 1 on PS403051); amends the Schedule to Clause 52.17 to identify native vegetation exempt from requiring a planning permit for removal; amends the Schedule to Clause 66.04 to require referrals for planning permit applications in the Yellow Gum and Emu Creek Local Town Centres to the Growth Areas Authority (Victorian Planning Authority); amends the Schedule to Clause 72.03 to update planning scheme maps, and amends the Schedule to Clause 72.04 to include new incorporated documents titled 'Lancefield Road Precinct Structure Plan', 'Incorporated Document for 3–5 Macedon Street, Sunbury, December 2018' and 'Incorporated Document for 170 Lancefield Road, Sunbury, December 2018'.
