

- (7) revoke Local Law No. 1 (Procedures for Council Meetings) 2017

# PROHIBITION OF FIREWORKS LOCAL LAW 2019

Notice is hereby given that Nillumbik Shire Council has resolved to make the following Local Law under section 111(1) of the Local Government Act 1989.

#### TITLE:

Prohibition of Fireworks Local Law 2019.

#### **PURPOSE:**

The objective of this Local Law is to prohibit the discharge of fireworks in certain parts of the municipality:

- to restrict activities in a bushfire prone rural environment that can impact on the health and wellbeing of residents, specifically those who have experienced catastrophic bushfires;
- to reduce the risk of danger and injury to animals and wildlife arising from the discharge of fireworks;
- to address nuisance, amenity and environmental impacts of fireworks activities; and
- apply standards that address safety matters directed at reducing risk to the community.

#### **GENERAL PURPORT:**

# Part 1 - Preliminary

This Local Law is the Prohibition of Fireworks Local Law 2019 and is made under Part 5 of the Local Government Act 1989.

This Local Law applies to land outside of the urban growth boundary within the Nillumbik Shire including the townships of St Andrews and Panton Hill.

#### Part 2 – Prohibition of Fireworks

A person must not discharge any fireworks on or from private property outside the urban growth boundary.

#### Part 3 – Administration

Introduces administration guidelines for the Prohibition of Fireworks Local Law 2019.

# Making of the Local Law

On 8 October 2019, Yarra City Council (Council) made a local law titled 'Consumption of Liquor in Public Places Law 2019' (the Local Law).

# **Purpose and General Purport**

The objectives of the Local Law are:

- to control the consumption and possession of liquor in public places within the municipal district, including where such consumption or possession may interfere with the amenity and enjoyment of public places or of land in the vicinity of public places;
- promoting the minimisation of alcohol-related harm by restricting the opportunity for unregulated public drinking within the municipal district;
- supporting the effective governance of the municipal district by promoting improved amenity of public spaces and discouraging anti-social behaviour;
- providing an effective means for police to deal with unregulated public drinking;
- improving the management of festivals and events to reduce risk to attendees, organisers, and Council; and
- the peace, order and good government of the municipal district.

The Local Law contains provisions related to:

- the prohibition of the consumption or possession of Liquor in a public place;
- the regulation of the consumption or possession of Liquor at a declared festival;
- the ability to consume, possess, or control liquor in an area that is a declared prescribed area;
   and
- the provision of powers to authorised officers to enforce the Local Law.



# PUBLIC NOTICE

Declaration of Boating Activity Exemption

Goulburn Murray Water as the declared waterway manager for Lake Hume, makes the following declaration under section 203(3) of the **Marine Safety Act 2010**.

For boating activity conducted by the Hume Boat Club, persons and vessels involved in the Hume Boat Club Race Day are exempt from the following requirements:

#### State Rules made under the Marine Act 1988

- 1. Clause 2(c) 5 knots within 50 metres of another vessel;
- 2. Clause 3(a) 5 knots within 50 metres of the water's edge;

# **Marine Safety Regulations 2012**

- 3. Regulation 96(5) the requirement to carry a bailer, bucket, torch, and paddles for competitor's vessels only; and
- 4. Regulation 97(1) the requirement to carry a fire extinguisher for competitor vessels only.

For boating activity conducted by Hume Boat Club 'Schedule 1 – Types of Personal Floatation Devices', of the Marine Safety Regulations 2012 (MSR) is modified to include a personal floatation device is a PFD Type 1, 2 or 3 if it complies with the current Hume Boat Club Racing Rules.

Subject to the conditions detailed below:

- Occupants of competing vessels must wear PFDs that comply with the current Hume Boat Club Rules.
- Masters of competing vessels are only exempt from item 1, 2, 3 and 4 for the duration of the
  event.
- The masters of rescue vessels are only exempt from Items 1 and 2 when undertaking a rescue operation to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety on shore.
- All persons on course and rescue vessels involved with the event must always wear a PFD during the event and vessels must have all prescribed safety equipment.
- In the event of any injuries which result in hospitalisation, a fatality or an incident involving a person or vessel not involved in the event, these must be immediately reported to MSV and Victorian Police. In the case of all other incidents, MSV requires incident reports within seven days and a finalised report within 30 days. This requirement must be complied with per Section 207(2) of the MSA.
- The exemptions and modification applies from 6.00 am to 6.00 pm Saturday 19 and Sunday 20 October 2019 for the waters at Lake Hume, bounded by buoys, south of Bethanga Bridge and adjacent to the Hume Boat Club at Bellbridge, provided that the stated safety controls and undertakings detailed in the Application for Boating Activity Exemptions and Exclusion Zones and associated documentation are adhered to.

# ORDER DECLARING A RESTRICTED AREA IN NORTH WEST VICTORIA FOR THE CONTROL OF QUEENSLAND FRUIT FLY AND MEDITERRANEAN FRUIT FLY

I, Jaclyn Symes, Minister for Agriculture, being of the reasonable belief that Queensland fruit fly is present in Victoria; and that Mediterranean fruit fly may be introduced into Victoria, make the following Order under section 32(1) of the **Plant Biosecurity Act 2010** declaring the area described in clause 6 and the Schedule to this Order to be a restricted area.

# 1 Objectives

The objectives of this Order are –

- (a) to declare a restricted area for the control of fruit fly in North West Victoria; and
- (b) to specify the prohibitions, restrictions and requirements which are to operate in relation to the restricted area.

# 2 Authorising provision

This Order is made under section 32(1) of the **Plant Biosecurity Act 2010** ('the Act').

#### 3 Commencement

This Order comes into operation on the day that it is published in the Government Gazette.

#### 4 Revocation

The Order entitled *Order declaring a restricted area in North West Victoria for the control of Queensland fruit fly and Mediterranean fruit fly* made under section 32(1) of the **Plant Biosecurity Act 2010**, and published in Victoria Government Gazette S501 on 24 October 2018, is **revoked**.

# 5 Definitions

In this Order -

**fruit fly** means Queensland fruit fly (*Bactrocera tryoni* (Froggatt)) and Mediterranean fruit fly (*Ceratitis capitata* (Weidemann)).

**host material** means the affected plants and plant products specified in clause 7.

# 6 Declaration of a restricted area for the control of fruit fly

The area described in the Schedule, known as the North West Victorian Restricted Area, is declared to be a restricted area for the control of fruit fly.

#### 7 Affected plants and plant products

This Order affects the following plants, and the fruits of such plants –

#### 8 Prohibitions, restrictions and requirements

- (1) The movement of any host material into the restricted area described in clause 6 and the Schedule is prohibited.
- (2) Subclause (1) does not apply to a person who brings any host material into the restricted area under and in accordance with a permit issued by an inspector under the Act and complies with any conditions set out in the permit.
- (3) Subclause (1) does not apply if the host material originates from an area for which there is currently in force an area freedom certificate, being a certificate issued by an officer responsible for agriculture in the State or Territory from which the host material originated certifying that the area from which the host material originated is known to be free of fruit fly.
- The owners and occupiers of land described in the Schedule must give an inspector (4) access to such land for the purposes of inspection, deployment of any lures or traps, application of any treatment or performance of any other actions which are necessary for the eradication or prevention of spread of fruit fly.

# 9 Inspector may issue directions

An inspector is authorised to issue a direction to a person owning or occupying any land found within the area described in clause 6 and the Schedule requiring the person to –

- (a) strip any host material from plants, and collect and dispose of that material; or
- (b) treat or destroy that material.

# 10 Expiry

This Order remains in force for a period of 12 months after the date that it is published in the Government Gazette.

#### Schedule

The area of land bounded by a line commencing at the intersection of Lacey Avenue and the border of Victoria and South Australia; then in a straight line directly east to Berribee Tank Track, then in a straight line directly north to the border of New South Wales and Victoria, then in a generally north-westerly direction along the border of New South Wales and Victoria to the intersection of the border of New South Wales and Victoria and South Australia, then in a southerly direction along the border of Victoria and South Australia to the point of commencement.

#### Notes

Section 33 of the Act provides that it is an offence for a person to cause or permit the movement of any plant, plant product, plant vector, used package, used equipment, earth material or beehive to which the declaration of the restricted area applies into, within or from that area or to contravene any prohibition, restriction or requirement specified in this order, unless authorised to do so by a permit issued by an inspector and in accordance with that permit. A maximum penalty of 60 penalty units applies in the case of a natural person and 300 penalty units in the case of a body corporate.

Section 35(2) of the Act provides that an order under section 32 may authorise an inspector to issue directions to any person to do any of the things listed in section 35(1). Section 35(4) of the Act provides that a person must not contravene any direction of an inspector under section 35(2). A penalty of 60 penalty units applies.

Terms used in this Order that are defined in the Act have that meaning.
