

At its meeting on 16 October 2019 the Greater Bendigo City Council adopted Greater Bendigo City Council Local Law – Process of Municipal Government (2020), which will come into effect on 1 January 2020.

Local Law – Process of Municipal Government (2020) replaces City of Greater Bendigo Process of Municipal Government Local Law, Local Law No. 8.

Local Law – Process of Municipal Government (2020) has the following objectives:

- (a) To regulate the use of the common seal of the municipality and to regulate the proceeding for election of Mayor and Deputy Mayor.
- (b) To regulate and control proceedings at meetings of the Council and Special Committees of the Council.
- (c) To promote and encourage good governance.

NOTICE OF AMENDMENT OF LOCAL LAW

General Local Law 2014 (Amendment 1 of 2019)

South Gippsland Shire Council propose to amend General Local Law 2014 to be referenced as General Local Law 2014 (Amendment 1 of 2019).

The purpose and general purport of the amendments to the local law are to –

- (a) include provisions that regulate the handling of dogs within Township areas to ensure a safe environment in which the residents of the municipal district enjoy a quality of life that meets the general expectations of the community;
- (b) regulate and control the activities of cats which may be dangerous or unsafe or detrimental to the quality of life in the environment of the municipal district;
- (c) increased provisions for recreation vehicles in the farming zone;
- (d) clarify the provisions for keeping of domestic animals;
- (e) introduce provisions for the protection of Council assets;
- (f) introduce provisions for the protection of municipal staff undertaking their normal duties;
- (g) general grammatical amendments throughout the Local Law.
