


Road Management Act 2004

DETERMINATION OF THE MONASH FREEWAY UPGRADE PROJECT – STAGE 2 TO BE A DESIGNATED ROAD PROJECT

I, the Hon. Jaala Pulford, Minister for Roads, under section 16 of the **Road Management Act 2004** determine as follows:

- 1 The road project known as the Monash Freeway Upgrade Project Stage 2 is a Designated Road Project.
- The road authority to which the Designated Road Project is assigned to is the Roads Corporation.
- The project area for the Designated Road Project is the area within City of Casey, comprising the parts of the road reserves shown by hatching and described in the legends on attached plans numbered GP DP 36A and GP DP 36B.
- The period during which this determination is to operate is from the day on which it is published in the Government Gazette until 31 December 2023 (including both of those days) or, if this determination is earlier revoked, until the day on which it is revoked (including both of those days).

DIRECTION TO THE ROADS CORPORATION WITH RESPECT TO MONASH FREEWAY UPGRADE PROJECT – STAGE 2

I, the Hon. Jaala Pulford, Minister for Roads:

- having determined that the road project comprising the Monash Freeway Upgrade Project
 Stage 2 (the Project) is a Designated Road Project (DRP) under section 16 of the Road Management Act 2004 (the Act);
- having specified the Roads Corporation as the road authority to which the DRP is assigned;
- having designated a project area with respect to the DRP;
- noting that the Roads Corporation may, pursuant to section 119(1)(b) of the Act, perform any road management function under the Act on any road in relation to a project assigned to the Roads Corporation by the Minister; and
- considering that it is in the public interest to do so –

direct Roads Corporation, pursuant to section 22 of the Act, to perform the functions and exercise the powers of a Coordinating Road Authority (CRA) and Responsible Road Authority (RRA) with respect to the DRP in the following manner –

- at all times in consultation with the City of Casey (the Council); and
- so far as is reasonably practicable, in accordance with any processes and policies that the Council would follow it were CRA and/or RRA with respect to the Project area.

I specify that this direction is to apply for the period of time during which the Project remains a DRP under section 16 of the Act.
