Crown Land (Reserves) Act 1978

ORDER GIVING APPROVAL TO THE GRANT OF A LICENCE UNDER SECTIONS 17B AND 17DA

Under sections 17B and 17DA of the **Crown Land (Reserves) Act 1978**, I, Lily D'Ambrosio MP, Minister for Energy, Environment and Climate Change, being satisfied that there are special reasons which make the granting of a licence reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a licence to Optus Mobile Pty Ltd by the Greater Geelong City Council as the Committee of Management, for a term of ten (10) years for the purpose of 'Track for access, cabling and electricity' over the area of Crown land being part of Mount Anakie Reserve described in the Schedule below and, in accordance with section 17B(3)(a) of the **Crown Land (Reserves) Act 1978**, state that –

- (a) there are special reasons which make granting the licence reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

SCHEDULE

The land indicated by red dashed line and labelled 'Optus access track' on plan marked 'M2155-G1B Revision A' and attached to the Department of Environment, Land, Water and Planning File No. 0701934 being portion of Allotment 86G, Parish of Anakie, being Crown land permanently reserved for the purpose of Conservation of an Area of Natural Interest by Order in Council of 15 September 1981 as published in the Government Gazette of 23 September 1981 page 3100.
