NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

Residential Tenancies Regulations 2020

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared for the proposed Residential Tenancies Regulations 2020 (the proposed Regulations).

The proposed Regulations, to be made under the **Residential Tenancies Act 1997**, are intended to replace the Residential Tenancies Regulations 2019.

The objective of the proposed Regulations is to prescribe certain information and requirements for the purposes of the **Residential Tenancies Act 1997**, as amended by the **Residential Tenancies Amendment Act 2018** for commencement on 1 July 2020.

The RIS examines the impact of the proposed Regulations and possible alternatives, and concludes that the proposed Regulations are the most efficient and equitable method of meeting the identified objectives.
