Electricity Standing Offer

Pursuant to sections 13, 35 and 39 of the **Electricity Industry Act 2000**, the following variations to electricity rates for the Victorian Default Offer and Standing offers for residential and small business customers of COVAU Pty Ltd, ABN 54 090 117 730 will take effect from 1 January 2020 until such time as the rates are further varied.

The weighted average tariff variation for affected residential electricity customers is an increase of 7.8%. The weighted average tariff variation for affected small business electricity customers is an increase of 8.0%. The main reason for the variation of our Victorian Default Offer and standing offer tariffs is due to changes in the cost of purchasing and supplying electricity, and in relation to the review of regulated Victorian Default Offer in respect to flat tariffs.

<sup>2</sup> **Units** 'c/kWh' = cents per kilowatt hour and is the unit of measurement for electricity. 'c/day' = cents per day. '\$/kW/month' = dollar per kilowatt per month and is the unit of measurement for electricity demand. '\$/kW pa' = dollar per kilowatt per month and is the unit of measurement for electricity demand. 'c/kW/day' = dollar per kilowatt per month and is the unit of measurement for electricity demand.

<sup>3</sup> **Daily Supply Charge** is a charge that applies for supplying electricity or gas to your premises for each day of the billing period, regardless of how much electricity you consume.

<sup>4</sup> **Controlled Load (hot water and heating)** is a basic network tariff for electric hot water and/or storage space heaters using a time-switch. Only available to installations currently taking supply under these tariffs. Please refer to your distributor's website for details on the applicable time periods.

<sup>5</sup> **5-Day Time of Use** is a basic network tariff for residential and small business consumption where consumption charges vary based on Peak and Off Peak times. Please refer to your distributor's website for details on the applicable time periods.

<sup>6</sup> **Time of Use** is a basic network tariff applicable to residential customers with Interval (Smart) meters installed. Please refer to your distributor's website for details on the applicable time periods.

<sup>7</sup> **7-Day Time of Use** is the basic network tariff for small business consumption where consumption charges vary based on Peak and Off Peak times. Please refer to your distributor's website for details on the applicable time periods.

<sup>8</sup> **Demand Tariff** is a cost-reflective demand tariff. Please refer to your distributor's website for details on eligibility and applicable time periods.
