Control of Weapons Act 1990

DECLARATION OF DESIGNATED AREA UNDER SECTION 10D(1)

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D(1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the City of Kingston that is within the area bounded by and including:

All public places within the City of Kingston that is within the area bounded by and including eastern side of Station Street, between Franklin Avenue and Maury Road, Maury Road from Station Street to the water line on Chelsea Beach, Franklin Avenue between Station Street and the water line at Chelsea Beach, and the water line on Chelsea Beach between Maury Road and Franklin Avenue.

For removal of doubt this area includes all the beach foreshore area up to and including the water line. A map of the designated area can be found at: www.police.vic.gov.au/public-notices

This declaration will operate on Wednesday 18 December 2019, between 12.00 pm and 11.59 pm. During these times members of the police force are authorised to exercise the following powers:

- (a) in a public place in the designated area, without warrant, stop and search for weapons:
 - (i) any person;
 - (ii) anything in the possession or control of the person;
 - (iii) any vehicle with a person in or on the vehicle; and
 - (iv) anything in or on such vehicle;
- (b) detain a person or vehicle for so long as is reasonably necessary to conduct a search;
- (c) seize and detain any item the member reasonably suspects is a weapon; and
- (d) request a person who is the subject of a full search to disclose his or her identity, and
- (e) direct a person to leave the designated area if the police officer reasonably believes the person is wearing the face covering primarily to:
 - (i) conceal their identity: or
 - (ii) to protect them from the effects of a crowd control substance; and the person refuses to remove the face covering when requested to do so.
- (f) direct the person to leave the designated area if the police officer reasonably believes the person intends to engage in conduct that would constitute an affray (section 195H Crimes Act 1958) or violent disorder (section 195I Crimes Act 1958).

All public places within the City of Kingston that is within the area bounded by and including eastern side of Albert Street, between McDonald Street and Park Street, along the northern edge of the Mordialloc Creek to the western end of Mordialloc Pier, McDonald Street to Nepean Highway across to Epsom Road to the water line on Mordialloc Beach, the water line on Mordialloc beach from Epsom Road to the edge of Mordialloc Creek. For removal of doubt this area includes all the beach foreshore area up to and including the water line.

This declaration will operate on Wednesday 18 December 2019, between 12.00 pm and 11.59 pm. During these times members of the police force are authorised to exercise the following powers:

- (a) in a public place in the designated area, without warrant, stop and search for weapons:

 - (iii) any vehicle with a person in or on the vehicle; and
 - (iv) anything in or on such vehicle;
