## Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN  
CITY OF GREATER GEELONG AND HOBSONS BAY CITY COUNCIL FOR THE 2020  
BAY CYCLING CLASSIC ON FRIDAY 3 JANUARY 2020, SATURDAY 4 JANUARY 2020  
AND SUNDAY 5 JANUARY 2020

### 1 Purpose

The purpose of this Declaration is to exempt participants in the 2020 Bay Cycling Classic from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Friday 3 January 2020, Saturday 4 January 2020 and Sunday 5 January 2020.

### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

### 3 Commencement

This notice takes effect on 12.30 pm on Friday 3 January 2020, 1.00 pm on Saturday 4 January 2020 and 10.00 am on Sunday 5 January 2020.

### 4 Expiry

This notice expires at 7.30 pm on Friday 3 January 2020, 7.30 pm on Saturday 4 January 2020 and 4.00 pm on Sunday 5 January 2020.

### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the 2020 Bay Cycling Classic, to be held on Friday 3 January 2020, Saturday 4 January 2020 and Sunday 5 January 2020; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of Cycling Events Pty Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

### 6 Declaration

I, Neil Byrne, as delegate of the Minister for Roads, Road Safety and the TAC, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
