NOTICE OF THE REVOCATION AND DECLARATION OF DECLARED SMOKING AREAS UNDER SECTION 3E OF THE TOBACCO ACT 1987

I, Jenny Mikakos, Minister for Health and Minister responsible for the administration of the **Tobacco Act 1987** ('the Act'), acting under section 3E of the Act:

- a. revoke the declaration published in Government Gazette S311 on 30 September 2011 that was made under section 3E(1) of the Act; and
- b. being satisfied that the areas in Crown Casino listed below and shaded in the floor plans contained in the Schedule to this Notice are high roller rooms within the meaning of the Act, declare these areas to be declared smoking areas under the Act.

The revocation and declaration will take effect on and from 31 December 2019.

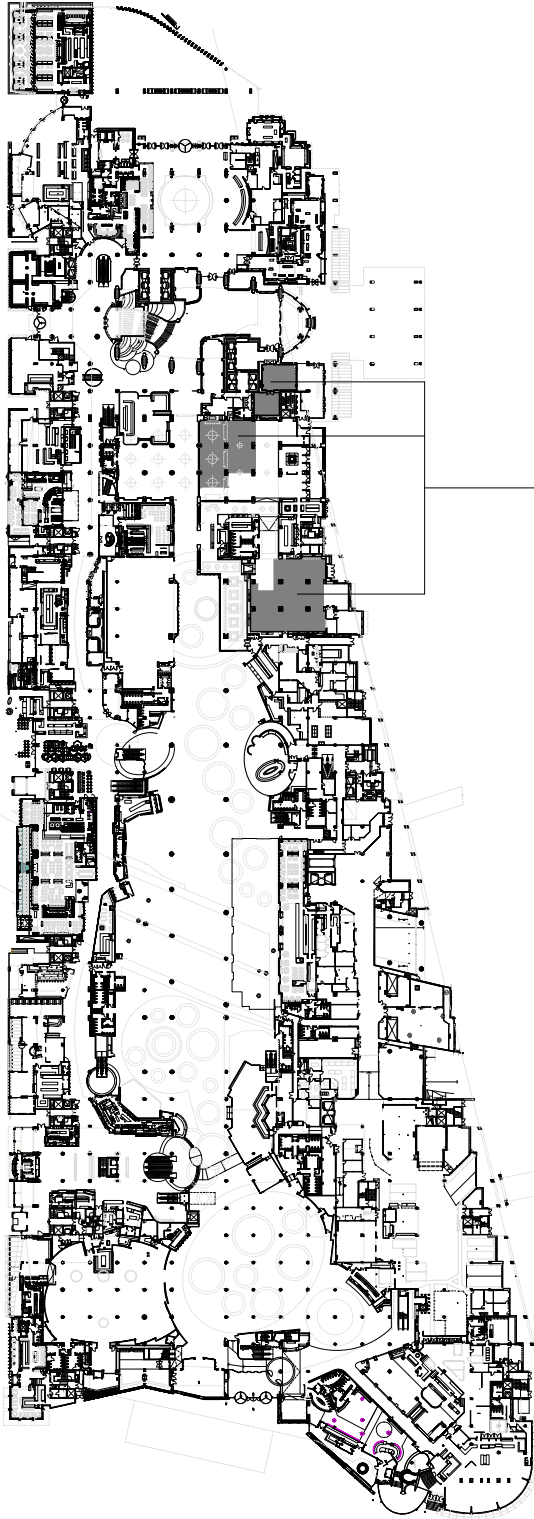

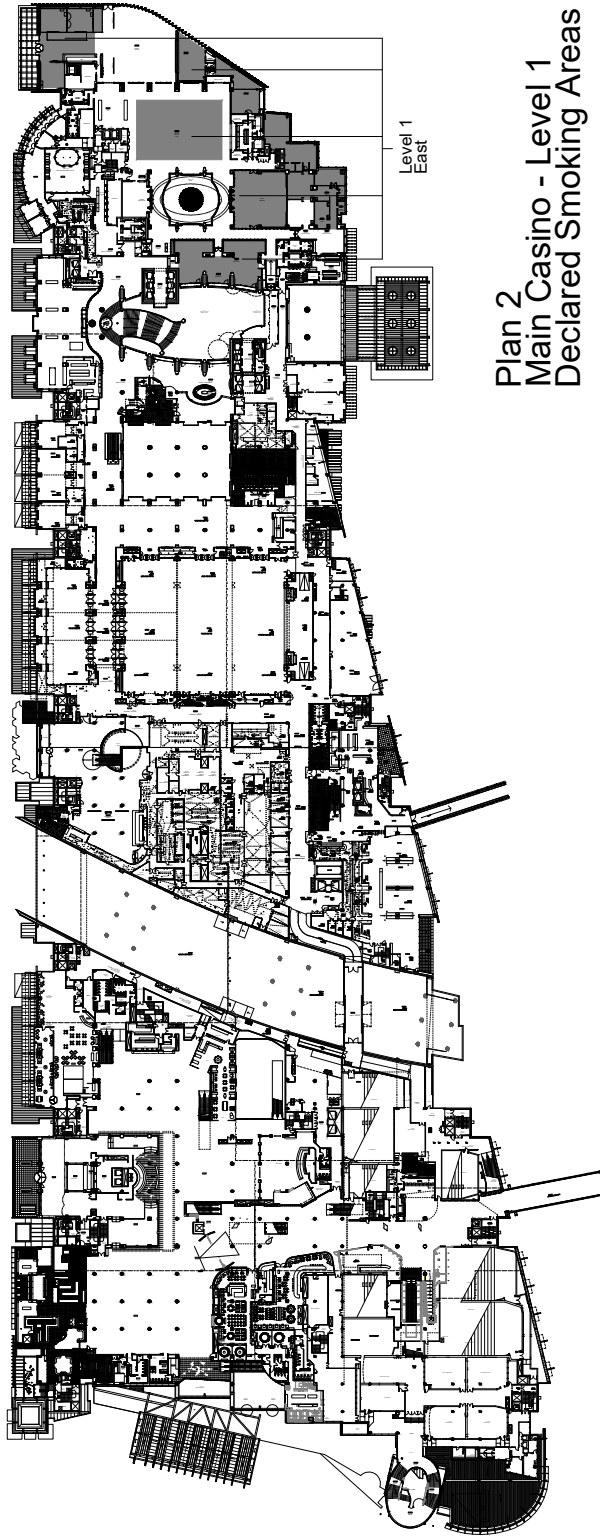

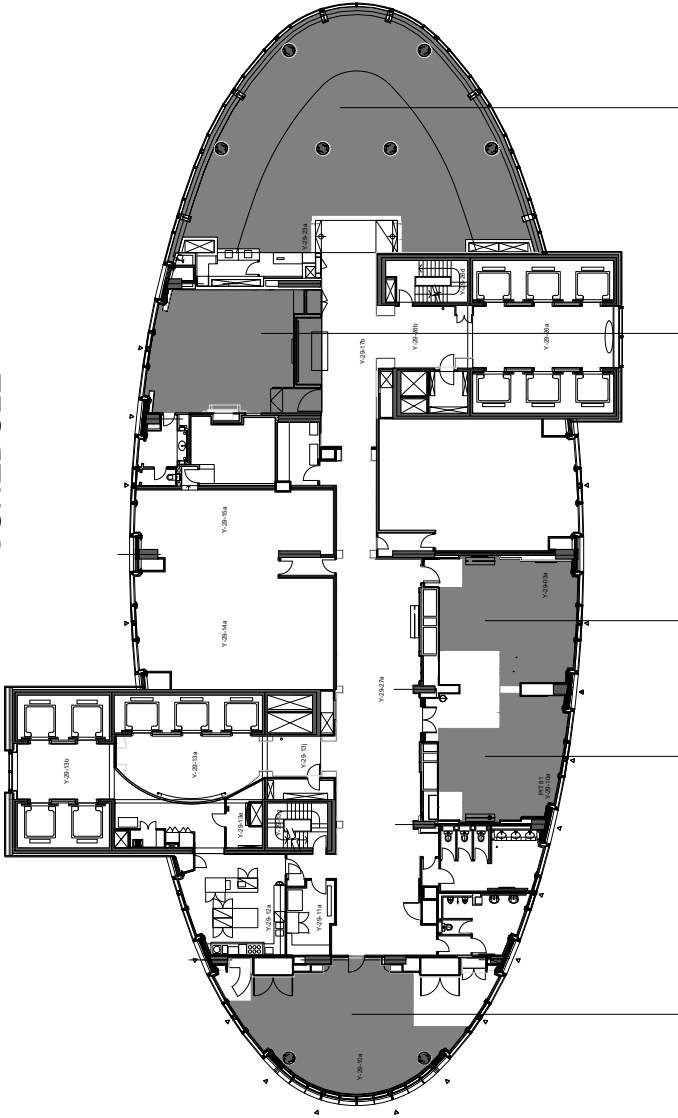


**Plan 2

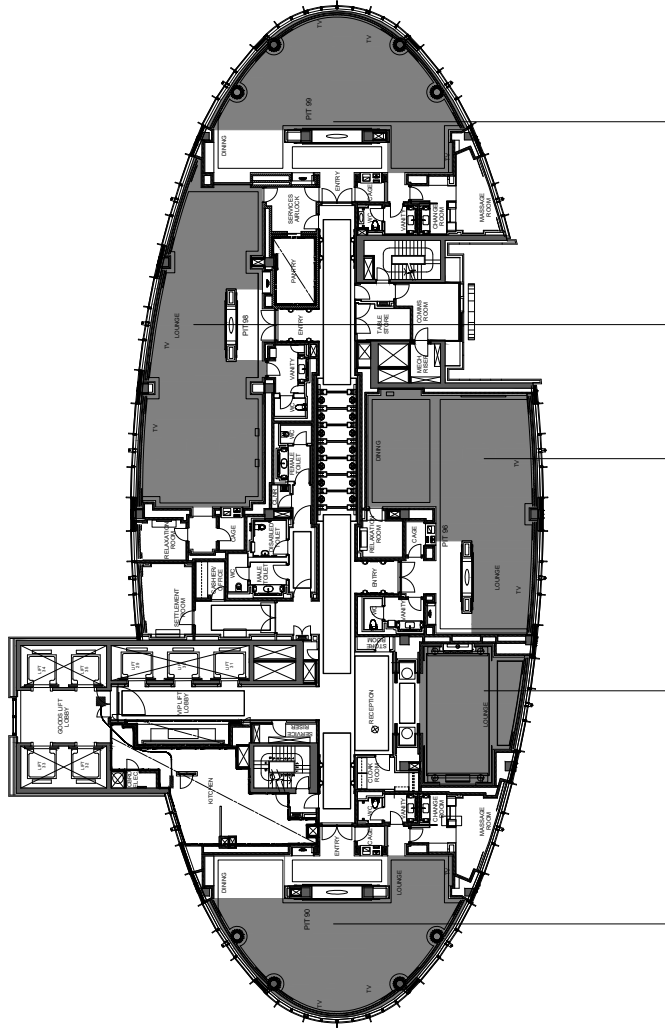

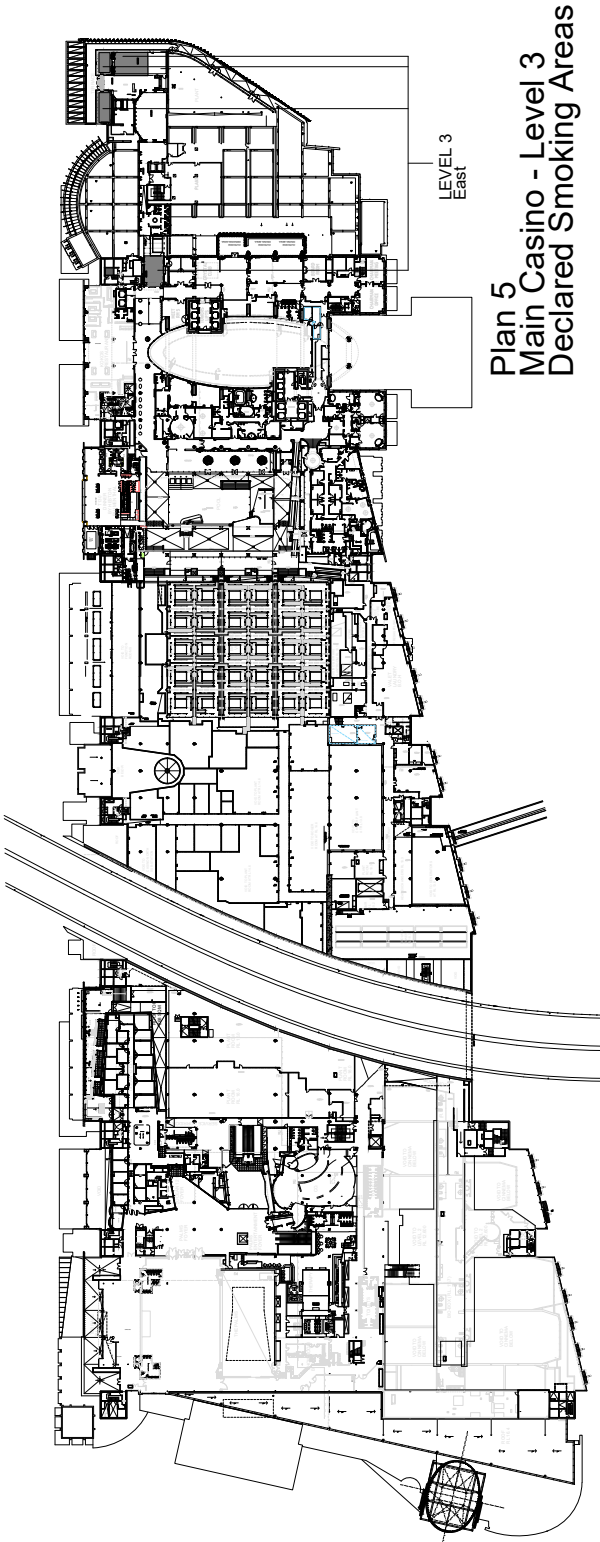
