	(3)	If a provision referred to in subsection (2) does not come into operation before 31 August 2020, it comes into operation on that day.		
48/2019	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
	(2)	If a provision of this Act does not come into operation before 27 August 2020, it comes into operation on that day.		
49/2019	(1)	This Part and Division 3 of Part 2, section 66(2), Division 1 of Part 3, sections 117 to 119, 144, 148, 150 to 153, 155 and 195A and Part 8 come into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.		
	(3)	If a provision referred to in subsection (2) does not come into operation before 30 June 2021, it comes into operation on that day.		
50/2019	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
	(2)	If a provision of this Act does not come into operation before 1 July 2020, it		

comes into operation on that day.
