ROAD DECLARATIONS AND DISCONTINUANCE

ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares, revokes and renames the roads described in Schedule A and on the plans attached.

ROAD DISCONTINUANCE

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the part of the road described in Schedule B and on the plan attached.

The effects of these Road Declarations and Road Discontinuance on road names are described in Table 1.

SCHEDULE A

ARTERIAL ROAD

- a) That part of Traralgon West Road identified by hatching on the plan numbered GP23397 is declared as described in the legend in the said plan.
- b) That part of Korumburra–Wonthaggi Road identified by hatching on the plan numbered GP23460 is declared as described in the legend in the said plan.
- c) Those parts of Pound Road identified by hatching on the plan numbered GP23234 are declared or renamed as described in the legend in the said plan.
- d) That part of Shrives Road identified by hatching on the plan numbered GP23234 is declared as described in the legend in the said plan.
- e) Those parts of Midland Highway identified by hatching on the plans numbered GP23695 and GP23696 are declared as described in the legend in the said plans.
- f) Those parts of Western Port Highway identified by hatching on the plan numbered GP23550 are declared as described in the legend in the said plan.

MUNICIPAL ROAD

- g) Those parts of Robinsons Road identified by hatching on the plan numbered GP23551 are declared as described in the legend in the said plan.
- h) Those parts of Bird Road, Glen Alvie Road and West Creek Road identified by hatching on the plan numbered GP23459 are revoked or declared as described in the legend in the said plan.

SCHEDULE B

ROAD

- a) That part of Bird Road identified by hatching on the plan numbered GP23459 is discontinued as described in the legend in the said plan.

3. Names in Column 2 may not apply to the whole length of the road and are for general information only.

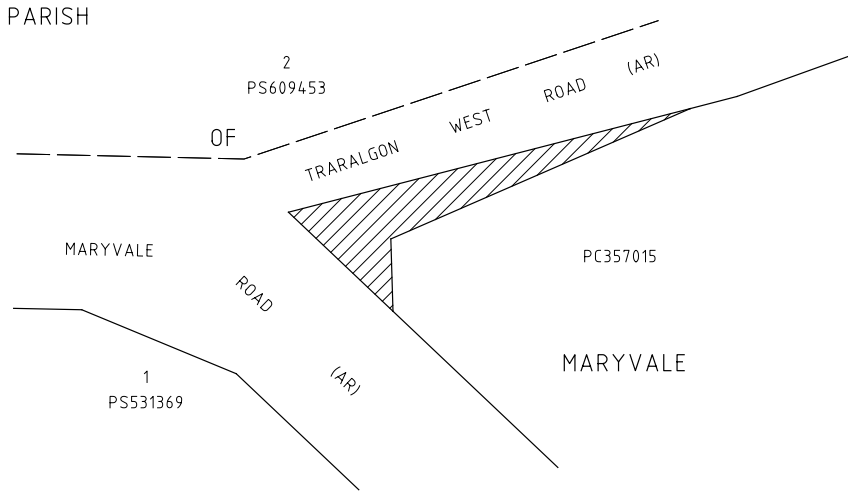
