#### Road Management Act 2004

#### DESIGNATION OF TOW-AWAY AREA UNDER SCHEDULE 4 CLAUSE 5

Tow-Away Area For 2019 St Kilda Festival

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a 'tow-away area'), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, Sameem Moslih, Director Journey Services of the Roads Corporation and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan, to be a tow-away area to help ensure safe traffic management for the 2019 St Kilda Festival.


This instrument takes effect at 12.00 am on Sunday 10 February 2019 and expires at 11.59 pm on Sunday 10 February 2019.

- Fitzroy Street, Balluk William Court to The Esplanade;
- Canterbury Road, Felix Lane to Fitzroy Street;
- Park Street, West Beach Road to Fitzroy Street;
- Acland Street, Beach Road to Fitzroy Street;
- Beach Road, Cowderoy Street to Shakespeare Grove;
- The Esplanade, Fitzroy Street to Carlisle Street;
- Carlisle Street, The Esplanade to Albert Street;
- Cavell Street, Beach Road to The Esplanade;
- Shakespeare Grove, Beach Road to Acland Street;
- Acland Street, Carlisle Street to Belford Street.


