






ROAD DISCONTINUANCE

Pursuant to section 206 and Schedule 10, Clause 3 of the **Local Government Act 1989**, the Greater Dandenong City Council, at its ordinary meeting held on 29 January 2018, formed the opinion that part of Pyke Street, part of Alexander Avenue and part of Dallimore Court, Dandenong, shown hatched on the plans below (Land), are not reasonably required as roads for public use and as such Council resolved to discontinue the roads and to retain them as part of Fotheringham Reserve.

The Land is to be retained subject to any right, power or interest held by a public authority in the Land in connection with any sewers, drains, pipes, wires or cables under the control of the authority in or near the Land.

The affected area is intended to be reserved under the **Crown Land** (**Reserves**) Act 1978 and the Council appointed as the committee of management.
