IN LEXUS LIFESTYLE MEDIA EVENT – PEAK AT THE PEAK ON
15 MAY 2019**1 Purpose**

The purpose of this Declaration is to exempt participants in the Lexus Lifestyle Media Event – Peak at the Peak from specified provisions of the *Road Safety Road Rules 2017* and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the arterial roads listed in Table 2 on Wednesday 15 May 2019.
