#### Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN CITY OF GREATER GEELONG FOR THE NISSAN SOCIAL MEDIA SHOOT ON TUESDAY 21 MAY 2019 OR THURSDAY 23 MAY 2019.

# 1 Purpose

The purpose of this Declaration is to exempt participants in the Nissan Social Media Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Tuesday 21 May 2019 or Thursday 23 May 2019.

## 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a nonroad activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect at 6.45 am on Tuesday 21 May 2019 or Thursday 23 May 2019 or when Victoria Police declare the road closed.

## 4 Expiry

This notice expires at 5.45 pm on Tuesday 21 May 2019 or Thursday 23 May 2019 or when Victoria Police declare the road open.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) 'Event' means the Nissan Social Media Shoot, to be held on Tuesday 21 May 2019 or Thursday 23 May 2019; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of Guilty (Aust) Pty Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Paul Northey, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
