TRANSPORT RESTRUCTURING ORDER (ROADS CORPORATION) NO. 1/2019

Order in Council

This Order may be cited as the Transport Restructuring Order (Roads Corporation) No. 1/2019.

The Governor in Council under Division 2 of Part 4A of the **Transport Integration Act 2010** orders that:

1. Commencement

This Order comes into operation on 1 July 2019.

2. Definitions

2.1 In this Order –

'**conferred functions**' means the functions conferred on the Head, Transport for Victoria by paragraph 3 of this Order.

2.2 Terms used in this Order have the same meaning as that term has in the **Transport Integration Act 2010**, unless the context otherwise requires.

3. Conferred functions

The functions specified in Part A of Schedule 1 are conferred on the Head, Transport for Victoria.

4. Ongoing and concurrent conferral

- 4.1 The conferred functions are conferred on the Head, Transport for Victoria on an ongoing basis.
- 4.2 The conferred functions are to be performed or exercised concurrently by the Head, Transport for Victoria and the Roads Corporation (meaning that each of the Head, Transport for Victoria and the Roads Corporation may exercise the functions independently of the other).

5. Effect of conferral on the Head, Transport for Victoria

The conferred functions are conferred on the Head, Transport for Victoria only to the extent that the exercise or performance of the function does not require the exercise of a function, power or duty conferred exclusively on another person or body by or under another Act.

6. Application of s 87(2) of the Transport Integration Act 2010

- 6.1 Section 87(2) of the **Transport Integration Act 2010** applies to the Head, Transport for Victoria in exercising or performing the conferred functions.
- 6.2 References to the Roads Corporation in s 87(2) of the **Transport Integration Act 2010** are to be construed as references to the Roads Corporation and the Head, Transport for Victoria, or either the Roads Corporation or the Head, Transport for Victoria, as the case requires.

7. Construction of other Transport Integration Act 2010 provisions

Other references to the Roads Corporation in the **Transport Integration Act 2010**, or in instruments made under that Act, are to be construed as references to the Roads Corporation and the Head, Transport for Victoria, or either the Roads Corporation or the Head, Transport for Victoria, as the case requires, to the extent necessary to enable the exercise or performance by the Head, Transport for Victoria of the conferred functions.

8. Saving of Roads Corporation functions and acts

Nothing in this Order limits the capacity of the Roads Corporation to perform or exercise functions, powers or duties conferred on it by or under any Act, or affects any act lawfully done by the Roads Corporation.

9. Severability of any provision or part of this Order

If any provision or part of this Order is invalid, the invalid provision or part is severed, and the Order otherwise continues to be valid and of legal effect.

TRANSPORT RESTRUCTURING ORDER (PUBLIC TRANSPORT DEVELOPMENT AUTHORITY) NO. 1/2019

Order in Council

This Order may be cited as the Transport Restructuring Order (Public Transport Development Authority) No. 1/2019.

The Governor in Council under Division 2 of Part 4A of the **Transport Integration Act 2010** orders that:

1. Commencement

This Order comes into operation on 1 July 2019.

2. Definitions

2.1 In this Order –

'**conferred functions**' means the functions conferred on the Head, Transport for Victoria by paragraph 3 of this Order.

2.2 Terms used in this Order have the same meaning as that term has in the **Transport Integration Act 2010**, unless the context otherwise requires.

3. Conferred functions

- 3.1 The following functions are conferred on the Head, Transport for Victoria:
 - (a) the functions specified in Part A of Schedule 1;
 - (b) the functions specified in Column 1 of the Table in Part B of Schedule 1, to the extent described in Column 2 of the Table.
- 3.2 The conferred functions specified in Column 1 of the Table in Part B of Schedule 1 are to be construed, for the purposes of the exercise or performance of that function by the Head, Transport for Victoria, as if the text shown in strikethrough in Column 2 of the Table was deleted

4. Ongoing and concurrent conferral

- 4.1 The conferred functions are conferred on the Head, Transport for Victoria on an ongoing basis.
- 4.2 The conferred functions are to be performed or exercised concurrently by the Head, Transport for Victoria and the Public Transport Development Authority (meaning that each of the Head, Transport for Victoria and the Public Transport Development Authority may exercise the functions independently of the other).

5. Transfer Order and transfer of employees

- 5.1 Transfer of employees from the Public Transport Development Authority to the Secretary will be necessary by reason of this Order.
- 5.2 A Transfer Order is otherwise required to be made under Division 3 of Part 4A of the **Transport Integration Act 2010** in order to transfer property, rights and liabilities:
 - (a) from the Public Transport Development Authority to the Head, Transport for Victoria, insofar as the property, rights and liabilities relate to the conferred functions; and
 - (b) from the Public Transport Development Authority to the Secretary, insofar as the property, rights and liabilities of the Public Transport Development Authority relate to staff to be transferred from the Public Transport Development Authority to the Secretary.

6. Application of s 79AE(2) of the Transport Integration Act 2010

6.1 Section 79AE(2) of the **Transport Integration Act 2010** applies to the Head, Transport for Victoria in exercising or performing the conferred functions.

6.2 References to the Public Transport Development Authority in section 79AE(2) of the **Transport Integration Act 2010** are to be construed as references to the Public Transport Development Authority and the Head, Transport for Victoria, or either Public Transport Development Authority or the Head, Transport for Victoria, as the case requires.

7. Construction of other Transport Integration Act 2010 provisions

- 7.1 References to the Public Transport Development Authority in sections 120(1)(a), 125(1)(c), 125(1)(d), 132(1)(a) and s 132(2)(e) of the **Transport Integration Act 2010** are amended and are be construed as references to the Head, Transport for Victoria or the Public Transport Development Authority (as the case requires).
- 7.2 Other references to the Public Transport Development Authority in the **Transport Integration Act 2010**, or in instruments made under that Act, are to be construed as references to the Public Transport Development Authority and the Head, Transport for Victoria, or either the Public Transport Development Authority or the Head, Transport for Victoria, as the case requires, to the extent necessary to enable the exercise or performance of the conferred functions by the Head, Transport for Victoria.

8. Saving of Public Transport Development Authority functions and acts

Nothing in this Order limits the capacity of the Public Transport Development Authority to perform or exercise functions, powers or duties conferred on it by or under any Act, or affects any act lawfully done by the Public Transport Development Authority.

9. Limitation on power of direction

- 9.1 Nothing in this Order makes the Head, Transport for Victoria subject to direction by the Minister or the Secretary under section 64T of the Transport Integration Act 2010 in relation to the quantum of any amount payable under section 68 of the Rail Management Act 1996 for breach of a civil penalty provision within the meaning of that section.
- 9.2 The power of direction under section 64T of the **Transport Integration Act 2010** is to be construed as excluding a power to make a direction of the type described in paragraph 9.1.

10. Severability of any provision or part of this Order

If any provision or part of this Order is invalid, the invalid provision or part is severed, and the Order otherwise continues to apply.

The property, rights and liabilities specified in this Schedule are those specified in section 2 of this Schedule.

1. Definitions and Interpretation

1.1 Definitions

Expressions used in this Order have the meaning given to them in sections 3 and 66A of the **Transport Integration Act 2010**. In addition, unless the context otherwise requires:

Assets means the assets described in Annexure A and all other assets used by PTV employees in performing their duties as PTV employees.

Contracts means:

- (a) the agreements described or listed in Annexure B; and
- (b) all other agreements (not including contracts of employment) that relate to the employment of, or services and benefits provided to, PTV employees and which were entered into by or on behalf of PTV or to which PTV is a party or under which PTV has any rights or liabilities,

each as amended, supplemented or novated from time to time.

PTV means the Public Transport Development Authority, established under the **Transport Integration Act 2010**.

PTV employees means all employees of PTV other than the Chief Executive and the Tourist and Heritage Railways Registrar.

PTV records means all files, records and data and all other documents relating to the Assets, Contracts or the employment of, or services and benefits provided to, PTV employees.

1.2 Interpretation

Headings are for convenience only and do not affect interpretation. The following rules apply unless the context requires otherwise:

- (a) A reference to an agreement or document is to the agreement or document as amended, restated, supplemented, novated or replaced on or before the effective date of the Order of which this Schedule forms part.
- (b) If the description of an agreement or document includes reference to a specific amendment, restatement, supplement, novation or replacement, this is not to be taken to imply that a reference to the agreement or document does not include any subsequent amendment, restatement, supplement, novation or replacement as provided in paragraph (a), regardless of whether that subsequent amendment, restatement, supplement, novation or replacement was made or entered into before or after the date of the Order of which this Schedule forms part.

(c) Where:

- (i) PTV is referred to as being a party to or the beneficiary of an agreement or document or as the sender or recipient of a letter; and
- (ii) the agreement, document or letter was entered into, made, sent or received by the Secretary, the Director of Public Transport, the Public Transport Ticketing Body or Metlink Victoria Pty Ltd prior to the date on which PTV was established.

SCHEDULE 1

The property, rights and liabilities specified in this Schedule are those specified in section 2 of this Schedule.

1. Definitions and Interpretation

1.1 Definitions

Expressions used in this Order have the meaning given to them in sections 3 and 66A of the **Transport Integration Act 2010**. In addition, unless the context otherwise requires:

Assets means the assets described in Annexure A and all other assets used in relation to the performance of PTV's functions.

Book Debts and Prepayments means the amounts owing or due to PTV by trade and other debtors and prepayments by PTV to suppliers of goods and services to PTV in relation to the performance of PTV's functions.

Contracts means

- (a) the agreements described or listed in Annexure B; and
- (b) all other agreements (not including contracts of employment) which relate to the performance of PTV's functions and which were entered into by or on behalf of PTV or to which PTV is a party or under which PTV has any rights or liabilities, including Expired Contracts,

together with:

- (c) all bank guarantees and security deposits held by PTV or to which PTV is entitled in respect of those agreements; and
- (d) all rights or interest under any insurance policy relating to those agreements, each as amended, supplemented or novated from time to time.

Excluded Property means:

- (a) property, rights and liabilities that are transferred to the Secretary pursuant to Transfer Order (Public Transport Development Authority) No. 1/2019 made on the date of this Order:
- (b) property, rights and liabilities that are solely used by, or relate solely to, the Chief Executive or the Tourist and Heritage Railways Registrar;
- (c) all bus service contracts and associated agreements (including Expired Contracts) relating to the provision of regular passenger services made pursuant to section 26 of the Bus Services Act 1995; and
- (d) Proceedings and PTV records relating solely to the property, rights and liabilities referred to in paragraphs (a), (b) and (c).

Expired Contracts means all agreements or arrangements which relate to the performance of PTV's functions and which were entered into by or on behalf of PTV or to which PTV is a party or under which PTV has any rights or liabilities and that have expired or been terminated.

Intellectual Property means all the:

- (a) Intellectual Property Rights specified in Annexure C to this Order;
- (b) agreements relating to any right to use, or exercise the rights in, the Intellectual Property Rights in (a); and
- (c) other:
 - (i) Intellectual Property Rights; and
 - (ii) agreements relating to any right to use, or to exercise the rights in, the Intellectual Property Rights,

which relate to the property, rights and liabilities transferred under this Order, or which are owned, licensed or held by PTV.

Intellectual Property Rights includes without limitation all:

- (a) copyright and neighbouring rights, all proprietary rights in relation to inventions (including patents) and processes, trademarks (including goodwill), confidential information (including trade secrets and know how), designs, circuit layouts, trade names, business names and domain names;
- (b) other proprietary rights resulting from intellectual activity in the industrial, scientific, literary or artistic fields;
- (c) in respect of (a) and (b), above, whether the rights are:
 - (i) recognised as existing at law;
 - (ii) protected by statute, common law or in equity;
 - (iii) registered, unregistered or applied for; or
 - (iv) subject to renewals or extensions,

in Australia, or anywhere else in the world; and

(d) rights or remedies against any infringement of the rights specified in (a), (b) or (c), above.

Land means the land described in Annexure D, including all fixtures, fittings, plant and equipment on that land.

Proceedings means the proceedings described in Annexure E and any other claim or dispute (whether actual or pending) before any court, tribunal or commission to which PTV is a party (but not including any claim or dispute that relates to contracts of employment).

PTV means the Public Transport Development Authority, established under the **Transport Integration Act 2010**.

PTV records means all files, records and data and all other documents relating to the functions of PTV.

1.2 Interpretation

Headings are for convenience only and do not affect interpretation. The following rules apply unless the context requires otherwise:

- (a) A reference to an agreement or document is to the agreement or document as amended, restated, supplemented, novated or replaced on or before the effective date of the Order of which this Schedule forms part.

- (c) Where:
