Commercial Passenger Vehicle Industry Act 2017

DETERMINATION OF ACCREDITATION AND REGISTRATION FEES

- I, Aaron de Rozario, Chief Executive Officer of the Commercial Passenger Vehicle Commission, acting under delegation from the Commission, give notice that with the approval of the Minister for Public Transport, pursuant to section 282 of the Commercial Passenger Vehicle Industry Act 2017 the fees set out in the following table shall apply in respect of applications for commercial passenger vehicle registration, booking service provider registration and driver accreditation, the annual renewal of commercial passenger vehicle registration and the annual accreditation of accredited drivers.
- 2. Driver accreditation holders who transitioned from driver accreditation under the Transport (Compliance and Miscellaneous) Act 1983 by force of Division 4 of Schedule 3 to the Commercial Passenger Vehicle Industry Act 2017 will be exempt from paying the Driver Accreditation Annual Accreditation Fee until the date upon which their driver accreditation under the Transport (Compliance and Miscellaneous) Act 1983 would have expired.
- 3. This notice supersedes the Determination of Fees notice relating to applications for commercial passenger vehicle registration, booking service provider registration and driver accreditation, the annual renewal of commercial passenger vehicle registration and the annual accreditation of accredited drivers, published in the Government Gazette no. S 81 on 7 March 2019.
- 4. This determination takes effect on and from 1 July 2019.

- 3. This determination takes effect on and from 1 July 2019.
