Notice of Approval of Amendment Amendment C276boro

The Minister for Planning has approved Amendment C276boro to the Boroondara Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette

The Amendment introduces a permanent Heritage Overlay to eight new individual properties and two new precincts in Balwyn, Balwyn North and Deepdene. The Amendment also amends the Schedule to Clause 43.01 (Heritage Overlay) and Planning Scheme maps 4HO, 8HO, 9HO and 10HO to include eight new properties and two precincts in the Heritage Overlay.
