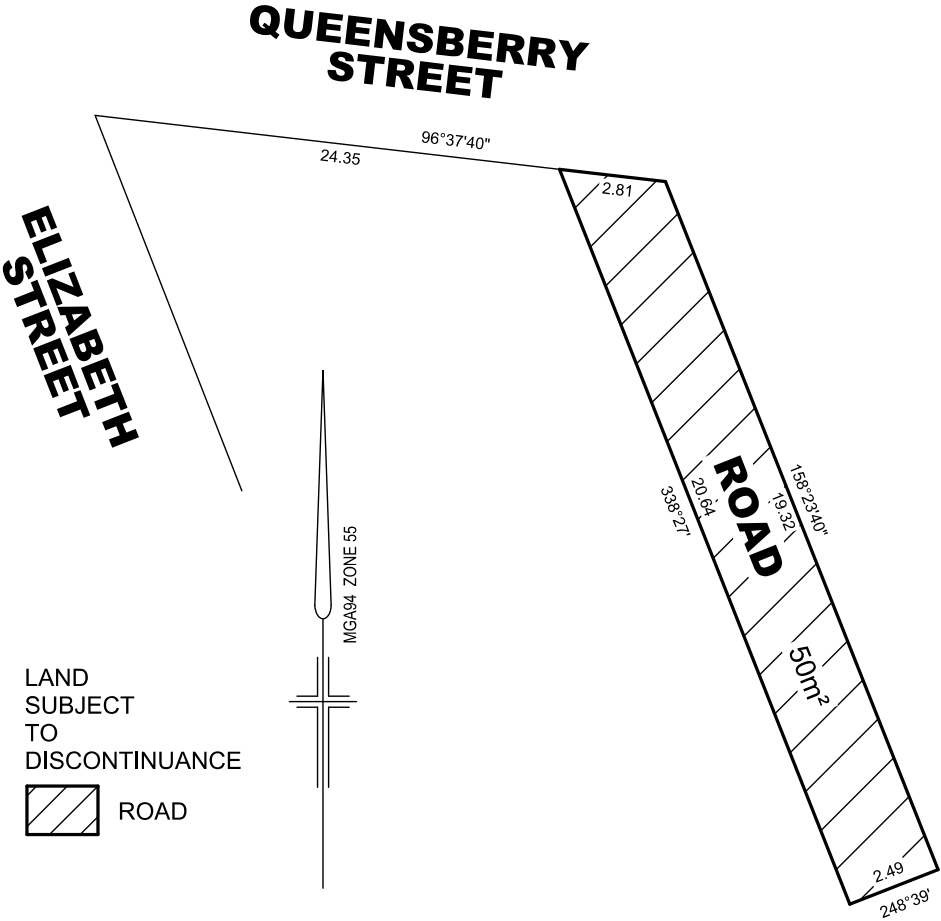

Purpose

Generally speaking, the proposed local law prohibits the drinking of alcohol (and the carrying of alcohol in open containers) in public places within the City of Yarra.

Some public places are excluded from these rules. These are known as 'prescribed areas'. Drinking and carrying alcohol in open containers is allowed in these areas between 9.00 am and 9.00 pm.

The proposed Local Law also empowers Yarra Council to vary these rules at certain times and places to facilitate festivals and events.

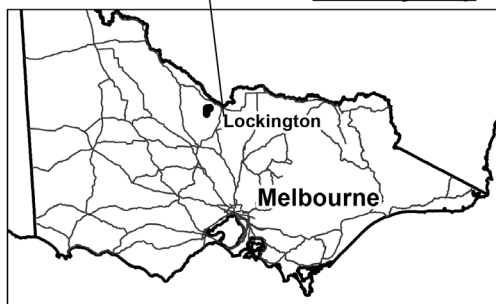

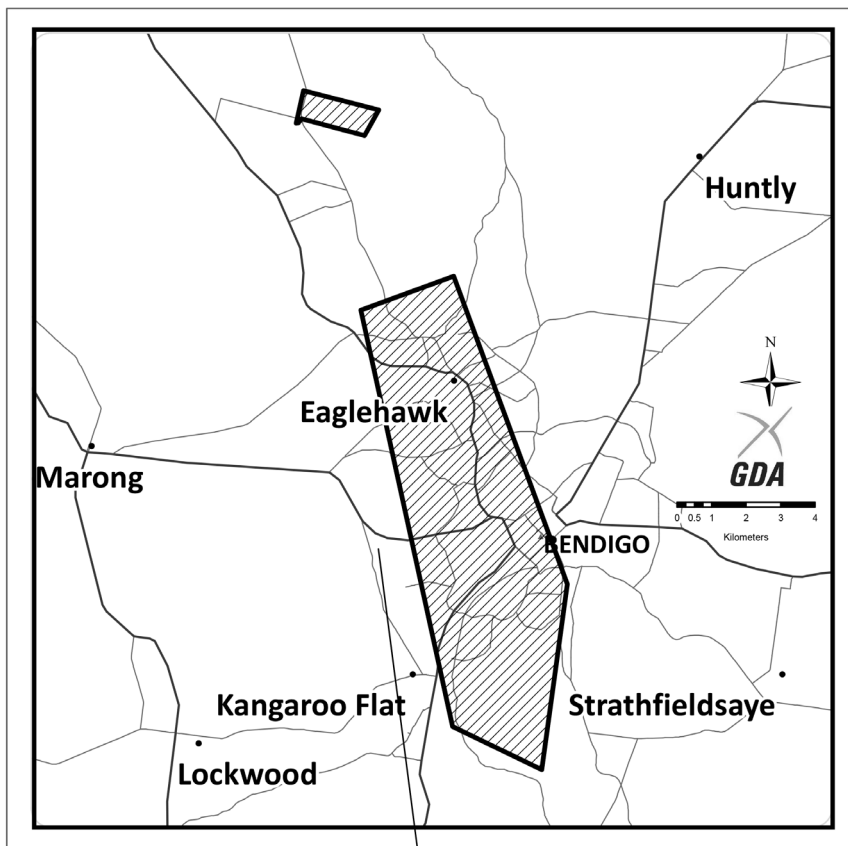
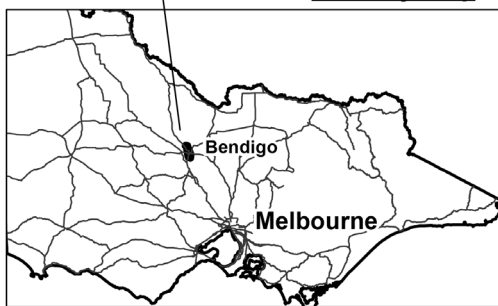
