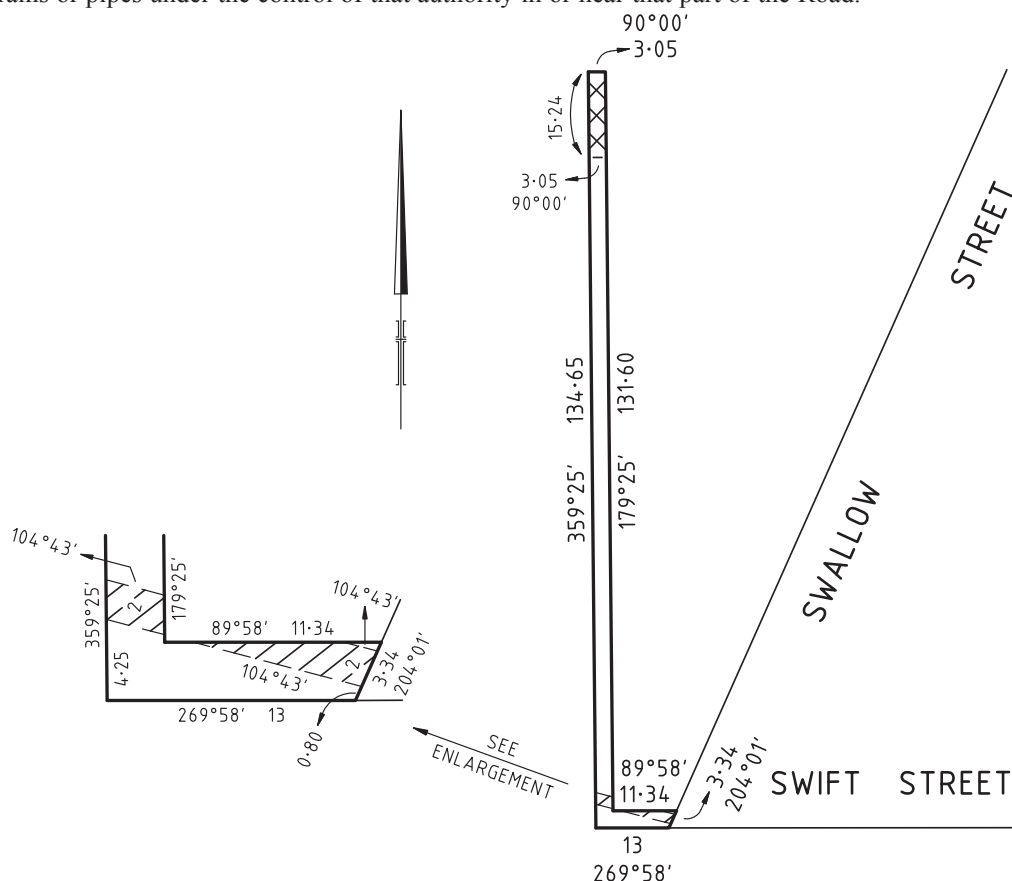

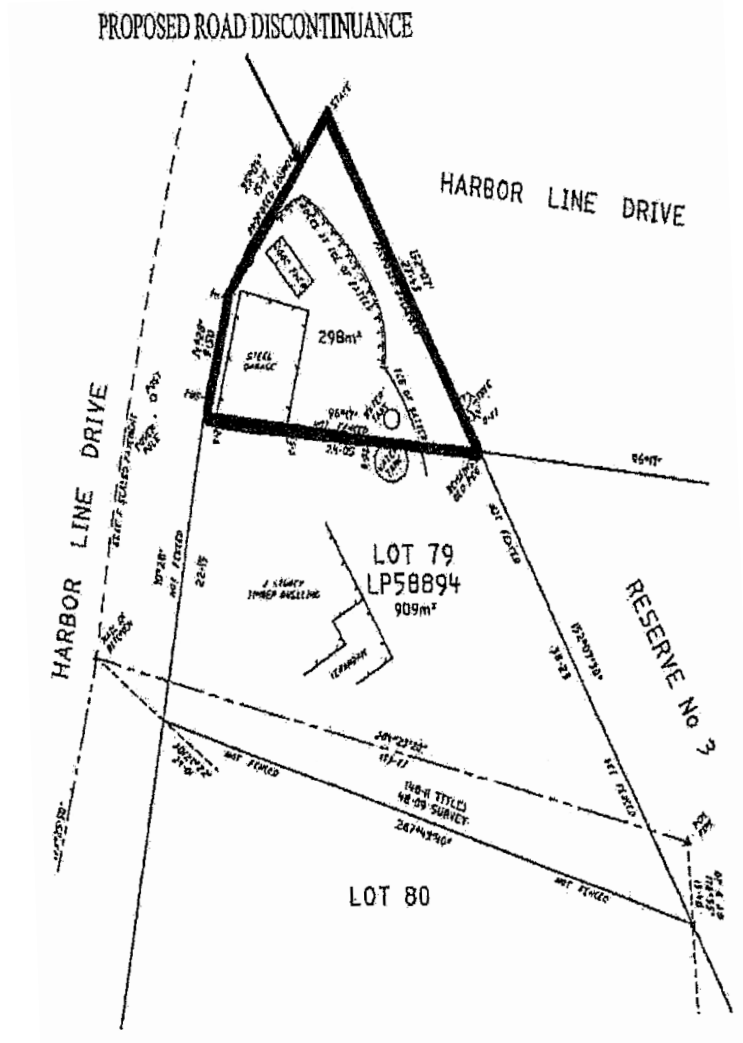

- to regulate the use of the common seal of the municipality and to regulate proceedings for elections of Mayor and Deputy Mayor;
- to regulate and control proceedings at meetings of the Council and Special Committees of the Council; and
- to promote and encourage good governance.

A fact sheet has been prepared to explain the background to and purpose for the development of the new Draft Local Law. The table below identifies the differences between the current Local Law 8 and the new Draft Local Law.

There are no substantive changes from the existing Local Law.

The penalty unit has been updated to reflect current values.

#### **NOTICE OF PROPOSED VARIATION OF THE CODE OF PRACTICE FOR TIMBER PRODUCTION 2014**

Notice is given under section 33 of the **Conservation, Forests and Lands Act 1987** of the proposed variation of the *Code of Practice for Timber Production 2014* (Code). Notice is also given under section 12I of the **Subordinate Legislation Act 1994** that a proposed Legislative Instrument and Regulatory Impact Statement (RIS) have been prepared in relation to the proposed variation of the Code.

#### **Background and objectives**

The Code provides the framework for the regulation of commercial timber harvesting operations on both public and private land and plays a key role in ensuring timber harvesting operations are compatible with the conservation of forests. The proposed variation of the Code builds on previous reviews to further clarify regulatory requirements, with the objectives being to ensure the Code is clearer, accurate and enforceable. The Code proposes to incorporate a new *Management Standards and Procedures for timber harvesting operations in Victoria's state forests*, which will include new protections for large trees and the Large Brown Tree Frog (*Litoria littlejohni*).

A RIS has been prepared to assess the benefits and impacts of the proposed Code variations to ensure they are efficient, maintain economic productivity and support community wellbeing. The RIS analysis focuses on the proposed new environmental protections by assessing one option for the protection of the Large Brown Tree Frog as recommended by its **Flora and Fauna Guarantee Act 1988** Action Statement and two options for protecting large trees (using regulatory prescriptions or a 20-metre protection buffer). The RIS determined that the most efficient option to implement the new environmental protections is to protect the Large Brown Tree Frog as recommended by its Action Statement and protecting large trees with regulatory prescriptions. The combination of these interventions is expected to protect important habitat characteristics that provide co-benefits for multiple threatened flora and fauna, while imposing minimal economic impact on the forestry sector.

#### **Submissions**

Public comments and submissions to the Minister for Energy, Environment and Climate Change are invited on the proposed variation of the Code, proposed Legislative Instrument and RIS. Submissions must be in writing and must be received by no later than midnight on 29 September 2019. The submissions will be considered before any variation of the Code is made.
