Notice of Approval of Amendment Amendment GC98

The Minister for Planning has approved Amendment GC98 to the Banyule, Boroondara, Manningham, Nillumbik, Whitehorse, Whittlesea and Yarra planning schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates the North East Link Project (project) by:

- applying the Specific Controls Overlay (SCO12) to land required for the project and allowing the use and development of that land in accordance with the specific control in the *North East Link Project Incorporated Document, December 2019* (incorporated document);
- applying the Design and Development Overlay (DDO) to land in Banyule and Manningham to ensure new development does not compromise the structural integrity or operation of project infrastructure;
- making the Secretary to the Department of Transport (and the Roads Corporation from 31 December 2030) the determining referral authority for applications under the DDO;
- making the Minister for Planning the responsible authority for administering and enforcing the provisions of the Banyule, Boroondara, Manningham, Nillumbik, Whitehorse, Whittlesea and Yarra planning schemes as they relate to the use and development of land for the project.
