# Road Safety Act 1986

## DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN BALLARAT FOR THE CYCLING AUSTRALIA ROAD NATIONAL CHAMPIONSHIPS ON WEDNESDAY 8 JANUARY 2020 TO SUNDAY 12 JANUARY 2020

## 1 Purpose

The purpose of this Declaration is to exempt participants in the Cycling Australia National Road Championships from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on roads listed in Table 2 from Wednesday 8 January 2020 to Sunday 12 January 2020.

# 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

# 3 Commencement

This notice takes effect on Wednesday 8 January 2020 at 11.00 am.

### 4 Expiry

This notice expires on Sunday 12 January 2020 at 6.00 pm.

### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires -

- a) 'Event' means the Cycling Australian Road National Championships to be held from Wednesday 8 January 2020 to Sunday 12 January 2020; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of the Event organiser, whose presence is reasonably required to ensure the safe conduct of the Event.

## 6 Declaration

I, Brian Westley, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2.
