Notice of Approval of Amendment

Amendment C174morept1

The Minister for Planning has approved Amendment C174morept1 to the Moreland Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment applies the Heritage Overlay on a permanent basis to 75 individual sites, 4 heritage precincts, 3 serial listings and 10 precinct extensions in Brunswick, Brunswick East, Brunswick West, Coburg, Coburg North, Glenroy, Fawkner, Fitzroy North, Oak Park, Pascoe Vale and Pascoe Vale South.

The Amendment also introduces 'The Moreland Heritage Exemptions Incorporated Plan 2019' into the Moreland Planning Scheme and rectifies anomalies in Clause 22.06 (Heritage) and in the Schedule to Clause 43.01 (Heritage) of the Moreland Planning Scheme.

The Minister for Planning has approved Amendment C284yara to the Yarra Planning Scheme.

The Amendment extends the expiry dates of the interim built form controls that apply to the Bridge Road (DDO21) and Victoria Street (DDO22) Activity Centres and to Collingwood South (Mixed Use) Precinct (DDO23) until 30 June 2021.
