## METROPOLITAN PLANNING STRATEGY

#### **Purpose**

The purpose of this Direction is to ensure that planning scheme amendments have regard to the Metropolitan Planning Strategy.

#### **Application**

**2**. This Direction applies to Metropolitan Melbourne.

#### **Definitions**

- 3. In this Direction:
- Metropolitan Melbourne has the meaning that it has in Clause 73.01 of the planning scheme.
  - Metropolitan Planning Strategy means the documents Plan Melbourne 2017-2050: Metropolitan Planning Strategy (Department of Environment, Land, Water and Planning, 2017) and Plan Melbourne 2017-2050: Addendum 2019 (Department of Environment, Land, Water and Planning, 2019)

#### Requirements to be met

- 4. In preparing a planning scheme amendment a planning authority must:
  - Have regard to the Metropolitan Planning Strategy.
  - Include in the explanatory report discussion of how the amendment addresses the following matters:
    - What aspects, if any, of the Metropolitan Planning Strategy are relevant?
    - How does the Metropolitan Planning Strategy affect the amendment?
    - Is the amendment consistent with the directions and policies in the Metropolitan Planning Strategy?
    - Does the amendment support, give effect to or assist the implementation of the Metropolitan Planning Strategy or can it be reasonably modified to do so?
    - Will the amendment compromise the implementation of the Metropolitan Planning Strategy?

#### **Exemption by Minister**

The Minister may grant an exemption from the need to comply with this Direction in relation to a particular amendment. An exemption may be granted subject to conditions.
