NOTICE OF THE PROPOSED DETERMINATION OF THE PORT PHILLIP BAY WHALE (DOLPHIN) SWIM TOUR LIMITED PERMIT AREA

I, James Todd, as delegate of the Secretary to the Department of Environment, Land, Water and Planning, in accordance with section 83G of the **Wildlife Act 1975**, propose to make the following determination under section 83F of the **Wildlife Act 1975**:

- 1. the area described in Schedule 1 is the Port Phillip Bay Whale (Dolphin) Swim Tour Limited Permit Area; and
- 2. the maximum number of whale swim tour permits to be granted in this area is three (3); and
- 3. 'dolphin' for the purposes of the determination means any wildlife that is a member of the family *Delphinidae* of the sub-order *Odontoceti* of the Order *Cetacea*, excluding Orcinus orca and members of the sub-family Globicephalinae (small toothed whales).



I, James Todd, as delegate of the Secretary to the Department of Environment, Land, Water and Planning, in accordance with section 83G of the Wildlife Act 1975, propose to make the following determination under section 83F of the Wildlife Act 1975:

- 1 the area described in Schedule 1 is the Port Phillip Bay Whale (Dolphin) Watching (Vessel) Tour Limited Permit Area; and
- 2. the maximum number of whale (dolphin) watching (vessel) tour permits to be granted in this area is one (1); and
- 3. 'dolphin' for the purposes of the determination means any wildlife that is a member of the family Delphinidae of the sub-order Odontoceti of the Order Cetacea, excluding Orcinus orca and members of the sub-family Globicephalinae (small toothed whales).


