### MINISTERIAL DIRECTION PURSUANT TO SECTION 61 OF THE **FISHERIES ACT 1995**

I, Jaala Pulford, Minister for Fishing and Boating, having applied the consultation principles in accordance with section 3A of the **Fisheries Act 1995** (the Act), pursuant to section 61 of the Act give a direction as follows:

The eligibility criteria that must be met before a person may be issued a Pipi Fishery Access Licence, is that person has to:

have held an Ocean Fishery Access Licence endorsed to take pipi and have a history of pipi catch taken between 1 January 2012 and 30 September 2013.

or

have held a Bait (General) Fishery Access Licence that was authorised to fish in Discovery Bay and have a history of pipi catch taken between 1 January 2012 and 20 September 2013.

This direction commences on 1 February 2020 and expires on 31 March 2020. Dated 20 January 2020
