Fisheries Act 1995

AMENDING ORDER - INITIAL QUOTA ORDER UNDER SECTION 64 - PIPI FISHERY

I, Jaala Pulford, Minister for Fishing and Boating having undertaken consultation in accordance with section 3A of the **Fisheries Act 1995**, make the following Order under section 64 of the Act.

- 1. This Order amends the Initial Quota Order under section 64 Pipi Fishery dated 13 February 2020 and published in the Victoria Government Gazette No. S 75 on 17 February 2020 (Original Order).
- 2. The Original Order is amended by:
 - in paragraph 5, substituting the subparagraph that defines **B**^E with the following: where **B**^E is equal to the total number of days fished in the Discovery Bay pipi zone by the individual Pipi Fishery Access Licence holder authorised to fish in the Discovery Bay pipi zone (as determined by the Chief Executive Officer of the Victorian Fisheries Authority) divided by the total number of days fished in the Discovery Bay pipi zone by all licence holders authorised to fish in the Discovery Bay pipi zone (as determined by the Chief Executive Officer of the Victorian Fisheries Authority);
 - b) in paragraph 5, substituting the subparagraph that defines **D**^E with the following: where **D**^E is equal to the total number of Pipi Fishery Access Licence holders authorised to fish in the Discovery Bay pipi zone.
 - c) in paragraph 6, substituting the subparagraph that defines **B**^w with the following: where **B**^w is equal to the total number of days fished in the Discovery Bay pipi zone by the individual Pipi Fishery Access Licence holder authorised to fish in the Discovery Bay pipi zone (as determined by the Chief Executive Officer of the Victorian Fisheries Authority) divided by the total number of days fished in the Discovery Bay pipi zone by all licence holders authorised to fish in the Discovery Bay pipi zone (as determined by the Chief Executive Officer of the Victorian Fisheries Authority);
 - d) in paragraph 6, substituting the subparagraph that defines **D**^w with the following: where **D**^w is equal to the total number of Pipi Fishery Access Licence holders authorised to fish in the Discovery Bay pipi zone.
