#### Road Safety Act 1986

#### DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN HOBSONS BAY FOR THE FILMING OF A TOYOTA YARIS TELEVISION COMMERCIAL FROM SATURDAY 7 MARCH 2020 TO MONDAY 9 MARCH 2020

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the filming of a Toyota Yaris Television Commercial from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 from 7 March 2020 to 9 March 2020.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister for Roads may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on 6 am on Saturday 7 March 2020.

#### 4 Expiry

This notice expires at 9 pm on Monday 9 March 2020.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires -

- a) 'Event' means the filming of a Toyota Yaris Television Commercial, to be held from 7 March 2020 to 9 March 2020; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of Red Sneakers, whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Neil Byrne, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by the Department of Transport and the municipal council.
