#### **Co-operatives National Law (Victoria)**

APPROVALS BY THE REGISTRAR OF CO-OPERATIVES

Sections 15(2)(g) and 607(3) of the Co-operatives National Law (Victoria)

#### 1. Approvals

I, Sam Jenkin, Registrar of Co-operatives, approve the following for the purpose of Part 5.4 of the **Corporations Act 2001** of the Commonwealth, as applied to co-operatives in Victoria by section 444 of the **Co-operatives National Law (Victoria)**:

- (a) For the purposes of paragraph (a) of the definition of statutory minimum in section 9 of the **Corporations Act 2001**, the amount approved is \$20,000.
- (b) For the purposes of paragraph (b) of the definition of statutory period in section 9 of the **Corporations Act 2001**, the period approved is 6 months.
- (c) For the purposes of section 459E(2)(e) of the **Corporations Act 2001**, the approved form is Form 509H of Schedule 2 of the Corporations Regulations 2001 of the Commonwealth, as in force from time to time, modified in the same manner as if Form 509H was an 'applied provision' for the purposes of section 15 of the **Co-operatives National Law (Victoria)**.

These approvals are made under section 15(2)(g) and section 607(3) of the **Co-operatives** National Law (Victoria).

#### 2. Application

- (a) The approval in paragraph 1(a) and paragraph 1(c) apply to all statutory demands served on co-operatives in Victoria on or after the date that this notice is published in the Victoria Government Gazette.
- (b) The approval in paragraph 1(b) applies to all statutory demands served on co-operatives in Victoria on or after 25 March 2020.

#### 3. Expiry

The approvals in paragraph 1(a) and 1(b) expire at the end of the period of 6 months starting on 25 March 2020.
