Notice of Lapsing of Amendment

The Minister for Planning has refused to approve Amendment C219case to the Casey Planning Scheme.

The Amendment proposed to amend the *Cranbourne West Precinct Structure Plan, May 2012* and Schedule 1 to the Urban Growth Zone to redesignate approximately 133 hectares of land known as 635 Hall Road, part of 620 Western Port Highway, and 690 Western Port Highway, Cranbourne from the Commercial 2 Zone to the General Residential Zone.

The Amendment lapsed on 3 April 2020.
