

MAKING OF SHORT STAY RENTAL ACCOMMODATION LOCAL LAW 2020

Notice is given pursuant to section 119(3) of the **Local Government Act 1989** that Frankston City Council ('Council'), at its meeting on 30 March 2020, resolved to make a local law titled 'Short Stay Rental Accommodation Local Law 2020' ('Local Law').

The purpose of the Local Law is to:

- regulate and control the use of short stay rental accommodation within the Council's municipal district;
- ensure an appropriate standard of management and presentation of such accommodation;
- minimise the risk of such accommodation affecting the peace of neighbours; and
- implement a registration requirement. The general purport of the Local Law is to:
- require and provide for the registration of short stay rental accommodation within the Council's municipal district;
- establish the conditions on which registration will be granted;
- establish the grounds on which registration may be cancelled;
- provide for review of registration decisions;
- establish the standards to which short stay rental accommodation must be managed;
- provide for the issuing of notices to comply in the case of a breach of the Local Law; and
- create offences for:
 - any failure to comply with the Local Law;
 - any failure to comply with a notice to comply;
 - acceptance of rental bookings in unregistered short stay rental accommodation;
 - making false complaints of breaches of the Local Law; and
 - making complaints about breaches of the Local Law outside business hours when the subject short stay rental accommodation is vacant.

DRUGS, POISONS AND CONTROLLED SUBSTANCES REGULATIONS 2017

Approval under Regulation 162 of the Drugs, Poisons and Controlled Substances Regulations 2017

Regulation 24 of the Drugs, Poisons and Controlled Substances Regulations 2017 (Regulations) enables a person who issues a prescription to write the prescription in a manner of writing approved by the Secretary under Regulation 162(1). The matters to which the Secretary must have regard in approving a manner of writing a prescription are set out in Regulation 162(2) of the Regulations, and include:

- (a) security;
- (b) legibility;
- (c) any other factors the Secretary considers relevant in the circumstances.

For the purposes of this approval, a person who issues an electronic prescription must comply with the Criteria for Electronic Prescriptions, listed below in addition to any requirements under the National Health (Pharmaceutical Benefits) Regulations 2017 (Commonwealth Regulations), the **Drugs, Poisons and Controlled Substances Act 1981** and the Regulations.

Criteria for Electronic Prescriptions

1. The software used to issue or receive the prescription must be listed on the Register of Conformance by the Australian Digital Health Agency with a current conformance identifier, and must comply with the current version of the Australian Digital Health Agency Electronic Prescribing Participating Software Conformance Profile.

- 2. The digital prescription message for each prescription must include:
 - the Healthcare Provider Identifier Organisation (HPI-O) of the practice or organisation from which the prescription is issued (Electronic Prescribing Conformance Profile requirement PRES-18), and
 - the Healthcare Provider Identifier Individual (HPI-I) (Electronic Prescribing Conformance Profile requirement PRES-19) or for an electronic prescription that is transmitted within a hospital a unique identifier that is managed and audited by that hospital, and
 - a unique prescription number (Electronic Prescribing Conformance Profile requirement PRES-18), and
 - the conformance identifier, except those electronic prescriptions that are transmitted within a hospital.
- 3. The electronic prescription must include information that confirms the identity of the authorised prescriber.
- 4. The software used to issue the prescriptions must:
 - manage defined roles with access rights that will only allow authorised persons to issue or receive electronic prescriptions for all medications, and
 - display the prescription and obtain a final approval from the prescriber prior to issuing a prescription for electronic distribution, and
 - utilise Electronic Prescribing Conformance Profile requirements to protect against fraud.
- 5. The software audit requirements (Electronic Prescribing Conformance Profile requirements PRES-10, PRES-38, PRES-39) will be capable of being accessed when required and must be produced on demand to an authorised officer.
- 6. The electronic prescription must comply with other requirements of the Drugs, Poisons and Controlled Substances Regulations 2017.



EXEMPTION OF DOMESTIC ANIMAL BUSINESSES FROM OPERATION OF ACT

Order in Council

- 1. The Governor in Council under section 5(1)(b) of the **Domestic Animals Act 1994** (the Act) exempts breeding domestic animal businesses keeping more than 10 relevant fertile female dogs on their registered premises from the operation of the provisions of the Act as set out in this Order.
- 2. Domestic animal businesses to which Clause 1 applies are exempt from the operation of section 54D of the Act until this Order is revoked.
- 3. The exemption set out in this Order is subject to the condition that a proprietor of a domestic animal business to which clause 1 applies must not acquire additional relevant fertile female dogs, unless the proprietor of the exempt domestic animal business is an approved commercial dog breeder.
- 4. The terms used in this Order have the same meaning as in the Act.
- 5. This Order has effect on and from the date of publication in the Government Gazette and has effect until it is revoked.
