Notice of Approval of Amendment

Amendment C375melb

The Minister for Planning has approved Amendment C375melb to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates development of the land for a new Australian Federal Police Melbourne State Office by applying Schedule 23 to Special Controls Overlay to the land and introducing the incorporated document *150 Lonsdale Street, Melbourne (Australian Federal Police – Melbourne State Office) – May 2020* into the Schedule to Clause 72.04.

The Minister for Planning has approved Amendment C383melb to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment extends the expiry dates of existing interim Heritage Overlays for 57 individual places and six precincts within the study area of the *Hoddle Grid Heritage Review 2018* for one year until 29 May 2021 and makes other administrative changes.
