Once an area has been declared to be a designated area, a police officer may give a person a notice under section 148B of the LCR Act banning that person from the area, or from all licensed premises in the area, for up to 72 hours from the time the notice is given to the person, if they suspect on reasonable grounds that the person is committing or has committed a specified offence as defined in section 3 of the LCR Act, wholly or partly in the area. In addition, a court may make an order under section 148I of the LCR Act to exclude a person who has committed a specified offence, as defined in section 3 of the LCR Act, wholly or partly in the area, from the area, all licensed premises in the area, specified licensed premises in the area, or licensed premises of a specified class in the area, for up to twelve months.

The impact of remaking the Orders as proposed and possible alternatives are examined in the RIS, and it is concluded that remaking the Orders as proposed is the most efficient and effective method of meeting the relevant objects of the LCR Act, particularly the primary object of harm minimisation, and supporting a long-term strategy to reduce or prevent the occurrence of alcohol-related violence or disorder in the identified areas.
