ROAD DECLARATIONS

The Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management** Act 2004, upon publication of this notice declares the roads described in Schedule A and on the plans attached.

ROAD DISCONTINUANCE

The Head, Transport for Victoria, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the part of the road described in Schedule B and on the plan attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE A

ARTERIAL ROAD

- a) That part of Midland Highway identified by hatching on the plan numbered GP23880 is declared as described in the legend in the said plan.
- b) Those parts of O'Shea Road identified by hatching on the plans numbered GP23816, GP23818, GP23819 and GP23820 are declared as described in the legend in the said plans.

SCHEDULE B

ROAD

a) That part of Road identified by hatching on the plan numbered GP23396 is discontinued as described in the legend in the said plan.


EFFECTS ON ROAD NAMES

- 3. Names in Column 2 may not apply to the whole length of the road and are for general information only.




