Amendment C365melb

The Minister for Planning has approved Amendment C365melb to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment replaces the interim Heritage Overlay applying to 372–378 Little Bourke Street, Melbourne, with a permanent Heritage Overlay and amends the heritage grading to 'non-contributory' within the Guildford and Hardware Laneways Precinct (HO1205).
