**Meat Industry Act 1993**

## PRIMESAFE DETERMINATION OF LICENCE CATEGORY AND FEES FOR VEHICLE-BASED MEAT PROCESSING FACILITIES

- 1) PrimeSafe, being the Authority established under section 43 of the **Meat Industry Act 1993** (the Act) –
  - a) pursuant to sections 44(f) and 45(2)(b) of the Act, determines Abattoir – Vehicle, as specified in Column 1 of the Table, to be a category of licence of a meat processing facility; and
  - b) pursuant to sections 44(h) and 45(2)(b) of the Act, fixes the application fee specified in Column 3 and the annual fee listed in Column 4 of the Table, in respect of an Abattoir – Vehicle licence based on the estimated annual throughput specified in Column 2.
- 2) In this instrument –
 

**annual throughput** means the number of units slaughtered or weight (tonnes) of material brought into the meat processing facility for processing (including storage) from 1 July 2020 to 30 June 2021;

**application fee** means the fee payable to PrimeSafe by the applicant on the making of an initial application under section 14(2) of the Act;

**annual fee** means the fee payable to PrimeSafe on the grant or renewal of a licence by a holder of an Abattoir – Vehicle licence;

**initial application** means the making, under section 14(1) of the Act, of an application for a licence to operate a meat processing facility in the Abattoir – Vehicle licence category.
- 3) This instrument comes into effect on the date it is published in the Government Gazette.
- 4) For the avoidance of doubt, this instrument does not affect any other instrument in which PrimeSafe has determined licence categories or fees for meat processing facilities.
