

Clause 53 – Dangerous and unsightly land – page 32 of Local Law No. 2 (Amendment)

Proposed change to increase the height limit for grass and weeds for fire hazardous and unsightly properties.

Clause 55 – Open air burning – page 33 of Local Law No. 2 (Amendment)

Proposed changes include adding 'industrial' areas to the prohibited burning zone; include maps of fire restriction zones to make it clearer

for residents, and the option for conditional burning permits to be issued for exceptional circumstances.

Clause 79 – Droving and moving of livestock – page 41 of Local Law No. 2 (Amendment).

Proposed changes to define the wording and to accurately reflect Council's position on the droving or moving of livestock within the municipality. Droving livestock across the municipality will be prohibited, however moving livestock between paddocks, that are not adjoining, may be allowed with a permit. Livestock owners do not require a permit when moving livestock directly across the road or between adjoining farms.

Trading Code of Practice

Trading Code of Practice was reviewed to include legislative changes to the **Tobacco Act 1987** for outdoor dining and drinking. The Trading Code of Practice formatting was also updated in line with Council's style guide and to make it more reader friendly for businesses.

EXEMPTION

Application No. H174/2020

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Torquay Bowls Club Inc. (the applicant). The application for exemption is to enable the applicant to organise and operate each year two women only and two men only lawn bowls tournaments and advertise those matters (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Allan Murphy and having heard from a representative of the applicant at a directions hearing on 6 July 2020, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

• The applicant wishes to continue to conduct two women only and two men only bowls tournaments each year. The applicant has been holding these tournaments for some 45 years and wishes to continue to do so. The tournaments are intended to provide an opportunity for members of the applicant club to engage in the game of bowls with their own gender. In particular, the applicant hopes that the women only days will increase the participation of women at the applicant club, including participating in mixed pennant bowls competitions. Other than the four tournaments which are the subject of this application, the applicant club provides opportunities for women and men to play in mixed gender pennant competitions.

- While acknowledging that the applicant club is particularly concerned to increase the participation of women in the sport, I am not satisfied on the material before me that any of the exceptions contained in the Act applies to the conduct. Without an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to consider properly the relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of women or men who wish to participate in the two tournaments restricted to the other gender. I am satisfied that for the purposes of this exemption, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from 16 July 2020 until 15 July 2025.

ORDER DECLARING A RESTRICTED AREA IN NORTHERN VICTORIA FOR THE CONTROL OF OUEENSLAND FRUIT FLY

I, Jaclyn Symes, Minister for Agriculture, being of the reasonable belief that Queensland fruit fly (*Bactrocera tryoni* (Froggatt)) is present in Victoria, make the following Order under section 32(1) of the **Plant Biosecurity Act 2010** declaring the area described in clause 6 and the Schedule to this Order to be a restricted area.

1. Objectives

The objectives of this Order are –

- (a) to declare a restricted area for the control of Queensland fruit fly in Victoria; and
- (b) to specify the prohibitions, restrictions and requirements which are to operate in relation to the restricted area.

2. Authorising provision

This Order is made under section 32(1) of the **Plant Biosecurity Act 2010** ('the Act').

3. Commencement

This Order comes into operation on the day that it is published in the Government Gazette.

4. Revocation

The Order entitled Order declaring a restricted area in northern Victoria for the control of Queensland fruit fly, made under section 32(1) of the **Plant Biosecurity Act 2010** and published in Victoria Government Gazette G27 on 4 July 2019 at pages 1304–1307, is **revoked**.

5. Definitions

In this Order -

Queensland fruit fly host material means the plants and plant products of the species specified in clause 7.

6. Declaration of a restricted area for the control of Queensland fruit fly

The area described in the Schedule, known as the Greater Sunraysia Pest Free Area, is declared to be a restricted area for the control of Queensland fruit fly.

7. Affected plants

This Order affects the following plants, and the fruits of such plants –

8. Prohibitions, restrictions and requirements

- (a) The movement of any Queensland fruit fly host material into the restricted area described in clause 6 and the Schedule is prohibited.
- (b) Subclause (1) does not apply to a person who brings any Queensland fruit fly host material into the restricted area under and in accordance with a permit issued by an inspector under the Act and complies with any conditions set out in the permit.
- (c) The owners and occupiers of land in the restricted area described in clause 6 and the Schedule must give an inspector access to such land for the purposes of inspection, deployment of any lures or traps, application of any treatment or performance of any other actions which are necessary for the eradication or prevention of spread of Queensland fruit fly.

9. Inspector may issue directions

An inspector is authorised to issue a direction to any owner or occupier of any land found within the area of land in the restricted area described in clause 6 and the Schedule requiring the owner or occupier to –

- (a) strip Queensland fruit fly host material from plants, and collect and dispose of that material; or
- (b) treat or destroy that material.

10. Expiry

This Order remains in force for a period of 12 months after the date that it is published in the Victoria Government Gazette.
