#### Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS NO. 5/2020 MADE UNDER SECTION 220D

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010**, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determines the following conditions (the Amending Conditions No.5/2020) which amend the Conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 23 December 2019, published in the Victoria Government Gazette No. S 558 dated Monday 23 December 2019, effective 1 January 2020, as amended previously by amending conditions published in the Victoria Government Gazette on Friday 28 February 2020 (No. S 96), Friday 3 April 2020 (No. S 178), Thursday 7 May 2020 (No. S 228) and Friday 12 June 2020 (No. S 282).

The Amending Conditions No. 5/2020 take effect from and including the day they are published in the Government Gazette.

#### Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS NO. 5/2020

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 23 December 2019, published in the Victoria Government Gazette No. S. 558 dated Monday 23 December 2019, effective 1 January 2020, as amended previously by amending conditions published in the Victoria Government Gazette on Friday 28 February 2020 (No. S 96), Friday 3 April 2020 (No. S 178), Thursday 7 May 2020 (No. S 228) and Friday 12 June 2020 (No. S 282) (the Conditions) are amended as follows:

- 1. In the paragraph immediately before the heading to Chapter 1A, for '1D' **substitute** '1E'.
- 2. After Chapter 1D, insert –

### 'CHAPTER 1E: TEMPORARY ACCEPTANCE OF PTV ASYLUM SEEKER ID CARDS EXPIRED 30 JUNE 2020

Despite any conditions to the contrary in Chapters 2 and 3, a PTV Asylum Seeker ID card with an expiry date of 30 June 2020 may continue to be used beyond its expiry date, by the eligible PTV ID card holder, as evidence of that card holder's current entitlement to travel using a concession ticket. This arrangement is applicable on and from 1 July 2020.

The arrangement is in place to accommodate delays in the processing of new PTV Asylum Seeker ID cards due to circumstances relating to the COVID-19 pandemic.

This is a temporary arrangement only and customers intending to continue to use a PTV Asylum Seeker ID should proceed with their application to obtain a new ID card as soon as possible.

Note: Advance notice will be given via PTV's website of the date that the expired PTV ID cards will no longer be accepted, prior to this condition ceasing to apply.

This arrangement does not apply to other forms of concession entitlement that may expire on 30 June 2020.'

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Conditions and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.
