Notice is given that at a meeting of Latrobe City Council (Council) held on 6 July 2020, Council proposed to make a Local Law titled 'Local Law No. 1, Meeting Conduct Local Law' (proposed Local Law).

The following information about the proposed Local Law provided in accordance with section 119(2) of the **Local Government Act 1989** (Act):

Purpose of the proposed Local Law

If made, the purposes of the proposed Local Law will be to:

- regulate the use of the Council's common seal;
- prescribe enforcement measures in relation to procedures to be set out in the Governance Rules of Latrobe City Council governing the conduct of Council meetings, and Delegated Committee meetings and Community Asset Meetings where applicable.

General purport of the proposed Local Law

If made, the proposed Local Law will revoke Meeting Procedure Local Law No. 1 2017 and:

- Provide for the administration of Council's Common Seal;
- Create offences for:
 - Misuse of Council's Common Seal;
 - Failure of a Councillor to withdraw an expression considered offensive or disorderly by the Chair;
 - Failure of a person who is not a Councillor to leave a meeting on the Chair's Order;
 - Failure of a Councillor to leave a meeting on the Chair's order or on Resolution of Council;
 - Failure of any person to comply with a lawful direction of the Chair at a meeting;
 - The fraudulent signing of a petition or joint letter which is presented to Council or has the intention of being presented to Council by any person;
 - Unauthorised recording or broadcasting of any part of a meeting.

Notice of the Preparation of an Amendment Amendment C238

The Cardinia Shire Council has prepared Amendment C238 to the Cardinia Planning Scheme.

The land affected by the Amendment is referred to as the 'Glismann Road Area' and includes 21 low density lots in Beaconsfield:

- 1 to 16 Glismann Road;
- 111 to 123 Old Princes Highway; and
- 11 Mahon Avenue.

The Amendment proposes to:

- rezone land within the 'Glismann Road Area' from the Rural Living Zone (RLZ1) and General Residential Zone (GRZ1) to the Neighbourhood Residential Zone (NRZ2) that recognises the natural topography, visual sensitivity and landscape features of the area;
- apply a Development Plan Overlay (DPO19) to facilitate an integrated design within an area of fragmented ownership and facilitate best practice planning initiatives in relation to subdivision layout, urban design, service provision and environmental considerations;
- apply a Development Contributions Plan Overlay (DCPO5) that shares the cost of key infrastructure items triggered by the new development in a fair and reasonable manner;
- facilitate the provision of local open space through the DCP (that would otherwise be collected under Clause 53.01 of the Cardinia Planning Scheme);

 incorporate the Glismann Road Development Contributions Plan into the Cardinia Planning Scheme. The Glismann Road Development Contributions Plan will be exhibited alongside this Amendment.

Plant Biosecurity Act 2010

ORDER DECLARING CONTROL AREAS IN VICTORIA FOR THE CONTROL OF GRAPE PHYLLOXERA

Order in Council

The Governor in Council, under section 19(1) of the **Plant Biosecurity Act 2010**, makes the following Order –

1. Purpose

The purpose of this Order is to declare control areas in Victoria for the purposes of preventing the spread of the pest grape phylloxera from the control areas to other parts of Victoria.

2. Authorising provision

This Order is made under section 19(1) of the **Plant Biosecurity Act 2010**.

3. Commencement

This Order comes into operation on the day it is published in the Government Gazette.

4. Revocation

The Order made under section 19(1) of the **Plant Biosecurity Act 2010** on 16 July 2019 declaring areas to be control areas for the control of grape phylloxera and published in Victoria Government Gazette G29 on 18 July 2019 at pages 1388–1393, is **revoked**.

5. Definitions

In this Order -

'grape phylloxera' means the pest Daktulosphaira vitifolii (Fitch);

'host material' means host plants; and earth material, package or used equipment associated with the cultivation, harvesting, handling, transport or processing of host plants;

'host plant' means plants and plant products of the genus Vitis, including potted vines, cuttings, rootlings, grapes, grape marc, grape must and germplasm.

6. Declaration of control areas for preventing the spread of grape phylloxera to other parts of Victoria

- a. The area described in the Schedule 1, known as the North East Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- b. The area described in the Schedule 2, known as the Nagambie Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- c. The area described in the Schedule 3, known as the Upton Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- d. The area described in the Schedule 4, known as the Mooroopna Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- e. The area described in the Schedule 5, known as the Maroondah Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.
- f. The area described in the Schedule 6, known as the Whitebridge Phylloxera Infested Zone, is declared to be a control area for the purpose of preventing the spread of grape phylloxera to other parts of Victoria.

7. Prohibitions, restrictions and requirements to apply in a control area

- a. For the purpose of preventing the spread of the pest grape phylloxera from a control area described in clause 6, the removal of any host material from a control area is prohibited.
- b. Subclause (1) does not apply to a person who removes table grapes from a control area described in clause 6 that have been treated for the control of grape phylloxera in accordance with the Act.
