WILDLIFE (PROHIBITION ON TAKING, DESTROYING AND HUNTING OF KANGAROOS UNDER AN AUTHORISATION ISSUED IN SUPPORT OF THE VICTORIAN KANGAROO HARVEST MANAGEMENT PLAN) NOTICE

I, Jaclyn Symes, Minister for Agriculture and I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, make the following Notice:

1. Objective

The objective of this Notice is to prohibit absolutely the taking, destroying and hunting of Eastern Grey Kangaroos and Western Grey Kangaroos in specified areas, which would otherwise be permitted under an authorisation issued in support of the Victorian Kangaroo Harvest Management Plan.

2. Authorising provision

This Notice is made under section 86 of the Wildlife Act 1975.

3. Commencement and period notice has effect

This Notice takes effect on 20 August 2020 and continues to have effect until 31 December 2020.

4. Prohibition on taking, destroying and hunting of kangaroos under an authorisation issued in support of the Victorian Kangaroo Harvest Management Plan

The taking, destroying and hunting of Eastern Grey Kangaroos and Western Grey Kangaroos under an authorisation issued in support of the Victorian Kangaroo Harvest Management Plan is prohibited during the period specified in this Notice in the specified areas described in the table below:

Area Name	Location
East Gippsland Shire	The entirety of the East Gippsland Shire.
Alpine Shire	The entirety of the Alpine Shire.
Towong Shire	The entirety of the Towong Shire.

5. Contravention of Notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
