Marine Safety Act 2010 Section 193(3)(b)(ii) ADVICE IN RELATION TO A NOTICE OF INTENTION TO REQUEST A WATERWAY RULE

I, Cameron Toy, Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rule for Lake Burrumbeet as submitted by the City of Ballarat on 7 August 2020 is of a material nature and that the City of Ballarat must comply with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rule under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires the City of Ballarat to invite submissions and comments in relation to the proposed requests from the public.
