MINISTERIAL INSTRUMENT OF DESIGNATION FOR THE PURPOSES OF THE AA ORDER AND GENERAL ORDER

- 3. state that designation under clause 1 also applies for the purpose of the arrangements regarding the **Public Health and Wellbeing Act 2008**, which are stated in the General Order;
- 4. specify that, for the purpose of this instrument of designation, the following definitions apply
 - (a) AA Order means Administrative Arrangements Order (No. 237) 2020;
 - (b) *General Order* means the current Administration of Acts General Order (as amended by any supplement to that Order) that is made by the Premier of Victoria and states the administrative arrangements for responsibility for Victorian Acts, provisions of Acts and functions;
- 5. specify that, if the designation of any place under clauses 1 to 3 above is, for any reason and, to any extent, ineffective, this does not affect:
 - (a) the designation of any other place under this instrument of designation; or
 - (b) the designation of that place, for any other purposes, under this instrument of designation.
