## Building Act 1993

### DETERMINATION THAT SPECIFIED AREAS ARE DESIGNATED BUSHFIRE PRONE AREAS

**1. Purpose**

The purpose of this instrument is to determine that specified areas are designated bushfire prone areas.

**2. Authorising Provisions**

This determination is made under section 192A of the **Building Act 1993** which provides that the Minister may determine that areas which are subject, or which are likely to be subject, to bushfires are designated bushfire prone areas.

**3. Commencement**

This determination comes into operation on the date of publication.

**4. Revocation**

The determination that Specified Areas are Designated Bushfire Prone Areas made by the Minister for Planning on 12 March 2020 and published in the Victoria Government Gazette (Special) No. S 152 Tuesday 24 March 2020 as amended is **revoked**.

**5. Determination**

For the purpose of section 192A of the **Building Act 1993**, I, John Bradley, as delegate of the Minister for Planning, as Minister responsible for the **Building Act 1993** determine that the areas coloured in fill in the Plans lodged in the Central Plan Office of the Department of Environment, Land, Water and Planning and listed in Column A of the Table below are designated bushfire prone areas.
